 THE ROTHERHAM BOROUGH COUNCIL (VARIOUS ROADS, ROTHERHAM)
 (TRAFFIC REGULATIONS CONSOLIDATION) ORDER 2005
 (AMENDMENT NO.3) ORDER 2005

1. Rotherham Borough Council in exercise of its powers under Section 1(1), 2(1) and (2) and 4(2) of Part IV of Schedule 9 to the Road Traffic Regulations Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 shall have effect as though:

(a) in relation to Schedule No.1 No Waiting At Any Time there were inserted the following words:

SCHEDULE NO.1
 NO WAITING AT ANY TIME

Doncaster Road, Clifton	the north-west side from a point 26 metres north east of the eastern kerb line of Cottenham Road for a distance of 217 metres in a south westerly direction
	the south-west side from a point 13 metres northeast of the north eastern kerb line of Middle Lane to its junction with the north eastern kerb line of Clifton Lane
Cottenham Road, Clifton	the north-east side from its junction with the northern kerb line of Doncaster Road for a distance of 97 metres in a north westerly direction

(b) there were included as 'Schedule 33 Waiting Limited to 30 minutes, no return within 30 minutes Mon-Fri 8.00 a.m – 6.00 p.m and there were inserted in Schedule 33 the following words:

SCHEDULE NO. 33
WAITING LIMITED TO 30 MINUTES, NO RETURN WITHIN 30 MINUTES
MON-FRI 8AM TO 6PM

Doncaster Road, Clifton

the north-west side from a point 178 metres
South west of the south western kerb line of
Cottenham Road for a distance of 71 metres
In a south westerly direction

(c) there were included as sub clause (14) of Clause 5 Limited Waiting under
Part 2 Waiting Restrictions the following words:

(14) between the hours of 8.00 a.m. and 6.00 p.m. on Monday to Friday
inclusive on any of the lengths and sides of road specified in Schedule
33 to this Order

(a) for a longer period than 30 minutes; or

(b) if a period of less than 30 minutes has elapsed since the termination
during the said minutes of the last period of waiting (if any) by that
vehicle on the same side of road

2. The Order shall come into force of the 5 day of December 2005 and may
be cited as "The Rotherham Borough Council (Various Roads,
Rotherham) (Traffic Regulations Consolidation) Order 2005 (Amendment
No.3) Order 2005
