## THE ROTHERHAM BOROUGH COUNCIL (THE SOUTH YORKSHIRE COUNTY COUNCIL (METER PARKING PLACES AND CONTROLLED PARKING ZONE) (ROTHERHAM) ORDER 1985) (AMENDMENT NO. 17) ORDER 1997

Rotherham Borough Council in exercise of its powers under Sections 1(1), 2(1) and (2) and 4(2), 32 and 45 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. The South Yorkshire County Council (Meter Parking Places and Controlled Parking Zone) (Rotherham) Order 1985 shall have effect as though:-
