THE ROTHERHAM BOROUGH COUNCIL (STREET PARKING PLACES) ORDER 1997 (AMENDMENT NO. 3) ORDER 1999

Rotherham Borough Council in exercise of its powers under Sections 1(1), 2(1) and (2), 4(2), 32 and 35 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following Order:-

1. The Rotherham Borough Council (Street Parking Places) Order 1997 shall have effect as though:-

(a) there were inserted in the Schedule thereto under columns 1 to 5 thereof the following items:-

1.17	All that part of the south western side of CATHERINE STREET from a point 7 metres south east of its junction with Percy Street for a distance of 17 metres in south easterly direction	3	Parallel to kerb	1 hour
1.18	All that part of the south western side of CATHERINE STREET from a point 31 metres south east of its junction with Percy Street for a distance of 10 metres in a south easterly direction	2	Parallel to kerb	1 hour
1.19	All that part of the eastern side of CORPORATION STREET from a point 45 metres north of its junction with the northern kerbline of Upper Millgate for a distance of 22 metres in a northerly direction	4	Parallel to kerb	1 hour
1.20	All that part of the eastern side of CORPORATION STREET from a point 29 metres north of its junction with the projection of the northern kerbline of Market Street for a distance of 24 metres in a northerly direction	4	Parallel to kerb	1 hour

- 1.21 All that part of the western side of CORPORATION STREET from a point 45 metres south of its junction with the southern kerbline of Bridge Street for a distance of 30 metres in a southerly direction 5 Parallel to kerb 1 hour
- 1.22 All that part of the northern side of DOMINE LANE from a point 12 metres east of the eastern kerbline of Market Street for a distance of 35 metres in an easterly direction 6 Parallel to kerb 1 hour
- 1.23 All that part of the southern side of DOMINE LANE from a point 16 metres east of the eastern kerbline of Market Street for a distance of 41 metres in a an easterly direction 7 Parallel to kerb 1 hour
- 1.24 All that part of the north western side of EASTWOOD LANE from a point 6 metres south west of the south western kerbline of Drummond Street Service Road for a distance of 30 metres in a south westerly direction 5 Parallel to kerb 1 hour
- 1.25 All that part of the north western side of EASTWOOD LANE from a point 50 metres south west of the south western kerbline of Drummond Street Service Road for a distance of 54 metres in a south westerly direction 9 Parallel to kerb 1 hour
- 1.26 All that part of the eastern side of HOWARD STREET from a point 12 metres south of the south eastern kerbline of Eastwood Lane for a distance of 36 metres in a southerly direction 6 Parallel to kerb 1 hour

| 1.31 | All that part of the south western side of MORPETH STREET from a point 30 metres south east of the south eastern kerbline of Eastwood Lane for a distance of 12 metres in a south easterly direction | 2 | Parallel to kerb | 1 hour |
| 1.32 | All that part of the north eastern side of NORFOLK STREET from a point 4 metres north west of the north western kerbline of Carlisle Street for a distance of 72 metres in a north westerly direction | 12 | Parallel to kerb | 1 hour |

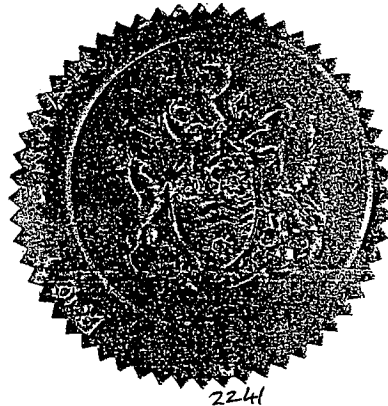
- 1.33 All that part of the south eastern side of NOTTINGHAM STREET from a point 8 metres north east of the north eastern kerbline of Norfolk Street for a distance of 37 metres in a north easterly direction 6 Parallel to kerb 1 hour
- 1.34 All that part of the south eastern side of PERCY STREET from a point 4 metres south west of the south western kerbline of Catherine Street for a distance of 101 metres in a westerly direction 17 Parallel to kerb 1 hour
- 1.35 All that part of the eastern side of PERCY STREET from a point 11 metres north of the northern kerbline of Doncaster Gate for a distance of 23 metres in a northerly direction 4 Parallel to kerb 1 hour
- 1.36 All that part of the south western side of WHARNCLIFFE STREET SERVICE ROAD from a point 7 metres south east of the south eastern kerbline of Eastwood Lane for a distance of 36 metres in a south easterly direction 6 Parallel to kerb 1 hour
- 1.37 All that part of the south western side of WHARNCLIFFE STREET SERVICE ROAD from a point 52 metres south east of the south eastern kerbline of Eastwood Lane for a distance of 12 metres in a south easterly direction 2 Parallel to kerb 1 hour
- (b) in Article 2(2) thereof in relation to the definition "charging hours"; after the word "charge" there were inserted the words ",payable between the hours of 8.00 a.m. and 6.00 p.m. on Monday to Saturday (inclusive),"
- (c) there were inserted in Article 20 thereof as paragraph (1)(a) the following words:-

"a vehicle left in a parking place between the hours of 6.00 p.m. and midnight and midnight and 8.00 a.m. on Monday to Saturday inclusive or a vehicle left in a parking place on any day being a Bank Holiday which shall include Christmas Day and Good Friday".

2. This Order shall come into force on the *10th* day of *May* 1999 and may be cited as "The Rotherham Borough Council (Street Parking Places) Order 1997)(Amendment No. 3) Order 1999".
