

THE ROTHERHAM BOROUGH COUNCIL
(EASTWOOD SOUTH, ROTHERHAM)
(RESIDENTS PARKING PLACES) ORDER 2007 (VARIATION)

1. Rotherham Borough Council ("the Council") in exercise of its powers under Sections 45, 46, 49, and 53 to the Road Traffic Act 1984 and of all other enabling powers, and after consultation with Chief Officer of Police in accordance with Part 3 of Schedule 9 to the Act hereby make the following Order;
2. This Order shall come into operation on the 27th October 2008 and may be cited as "The Rotherham Borough Council (Eastwood South, Rotherham)(Residents Parking Places) Order 2007 (Variation)
3. The Rotherham Borough Council (Eastwood South, Rotherham) (Residents Parking Places) Order 2007 shall have effect as though there were included in the Schedule headed Residents Parking Space Monday-Friday 9am-4pm the following words;

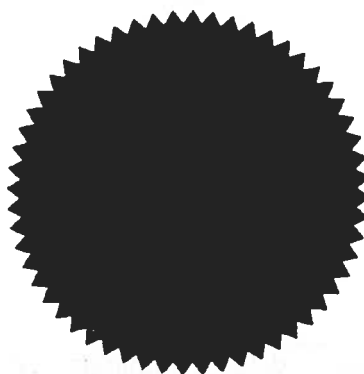
