(TRAFFIC REGULATION CONSOLIDATION) ORDER 2005
(AMENDMENT NO. 24) ORDER 2006

1. Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following Order:
2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2005 shall be varied as specified in the Schedule hereto.
3. The Order shall come into force of the 28th April 2008 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 (Amendment No. 24) Order 2006

SCHEDULE

- 1 Schedule No 42 (Pay and Display Maximum Stay 1 hour Mon-Sat 8am-6pm) is varied as follows:
 - 1.1 Main Street, Rotherham Town Centre
the north side from a point 73 metres west of the western kerbline of Westgate for a distance of 24 metres in a westerly direction

This section is revoked.
 - 1.2 Main Street, Rotherham Town Centre
the north side from a point 19 metres east of the eastern kerbline of Market Street for a distance of 16 metres in an easterly direction

This section is amended to:

Main Street, Rotherham Town Centre
the north side from a point 22 metres east of the eastern kerbline of Market Street for a distance of 30 metres in an easterly direction
 - 1.3 Main Street, Rotherham Town Centre
the south side from a point 25 metres east of the projected eastern kerbline of Market Street for a distance of 36 metres in an easterly direction

This section is amended to:

the south side from a point 25 metres east of the projected eastern
kerbline of Market Street for a distance of 30 metres in an easterly
direction

- 2 Schedule No 53 (Loading/Unloading Mon-Sat 8am-6pm) is varied as follows:

- 2.1 Main Street, Rotherham Town Centre
the north side from a point 16 metres west of the western kerbline
of Westgate for a distance of 17 metres in a westerly direction

This section is revoked.

- 3 Schedule No 1 (No Waiting at Any Time) is varied as follows:

- 3.1 Main Street, Rotherham Town Centre

- (i) the north side from its junction with the western kerbline of
Westgate for a distance of 34 metres in a westerly direction
- (ii) the south side from its junction with the western kerbline of
Westgate for a distance of 27 metres in a westerly direction

This section is amended to:

Main Street, Rotherham Town Centre

- (i) the north side from its junction with the western kerbline of
Westgate for a distance of 42 metres in a westerly direction
- (ii) the south side from its junction with the western kerbline of
Westgate for a distance of 35 metres in a westerly direction
