ROTHERHAM BOROUGH COUNCIL THE ROTHERHAM BOROUGH COUNCIL (VARIOUS ROADS, ROTHERHAM) (TRAFFIC REGULATIONS CONSOLIDATION) ORDER 2005 (AMENDMENT NO.30) ORDER 2007

- 1. Rotherham Borough Council in exercise of its powers under Section 1, 2 and 4 and of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:
- 2. The Rotherham Borough Council (Various Roads, Rotherham) Traffic Regulations Consolidation) Order 2005 ("the 2005 Order") shall have effect as though the definitions "carriageway" "postal packet", "telecommunications apparatus" and "verge" referred to in Article 2(1) below were included at: Part 1 General Definitions item 2(1) of the 2005 Order and the exemptions from verge parking were inserted at Part 2 item 10 of the 2005 Order and there were inserted in the "List of Schedules" item numbered 19 "Prohibition of Verge Parking" and included at Schedule 19 of the 2005 Order

PART 1 GENERAL

Definitions

2. (1) In this Order:-

"TMA 2004"	the Traffic Management Act 2004;
"carriageway"	means a way constituting or comprised in a highway being a way over which the public have a right of way for the passage of vehicles;
"civil enforcement officer"	means an officer employed by the Council under the provisions of the TMA 2004;
"motorcylce" and "invalid carriage"	have the meaning as in section 136 of the 1984 Act and includes any motor vehicle with less than 4 wheels;
"postal packet"	means a letter, parcel or other article transmissible by post as defined in section 125 of the Postal Services Act 2000;
"telecommunications apparatus"	meas the same meaning as in section 4 of the Telecommunications Act 1984;
"vehicle"	means a motor vehicle and a motor vehicle has the same meaning as in section 136 of the Act;
"verge"	means the grassed area between the edge of the carriageway and the highway boundary;

PART 2

Exemptions from verge parking

10.

- (i) No person except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer shall cause or permit any motorcycle, invalid carriage or vehicle to wait on the verges of those lengths and sides of roads specified in Schedule 19 to this Order;
- (ii) Nothing shall render it unlawful to cause or permit any vehicle to wait on the verges of those lengths and sides of roads specified in Schedule 19 to this Order for so long as it is necessary to enable:-
- (a) goods to be loaded on or unloaded from the vehicle;
- (b) the vehicle, if it cannot be used in connection with any other road to be used in connection with any of the following operations, namely;
 - (i) for the maintenance, improvement or reconstruction of the said lengths and sides or roads;
 - (ii) the laying, erection, alteration or repair in or adjacent to the said lengths and sides of roads for the supply of gas, water or electricity or of any telecommunication apparatus;
- (c) the vehicle if it cannot be conveniently used for such purpose in any other road to be used in the service of a local authority or water authority in pursuance of statuory powers or duties;
- (d) the vehicle to be used for the purpose of delivery or collecting postal packets;
- (e) the vehicle to be used for Fire Brigade, Ambulance or Police purposes;

- 3. The 2005 Order shall have effect as though there were deleted in Schedule 1 "No Waiting At Any Time" restrictions those lengths and sides of road specified in Schedule 1 to this Order;
- 4. The 2005 Order shall have effect as though there were included in Schedule 1 "No Waiting At Any Time" restrictions those lengths and sides of road specified in Schedule 2 to this Order;
- 5. The 2005 Order shall have effect as though there were included in Schedule 19 "Prohibition of Verge Parking" those lengths and sides of road specified in Schedule 3 to this Order

Schedule 1 deleted "No Waiting At Any Time"

Herringthorpe Valley Road, Stag

- (i) the east side from its junction with the southern kerb line of Laudsdale Road for a distance of 358 metres in a southerly direction
- (ii) the south and west side from its junction with Stag Lane for a distance of 178 metres in an easterly and south-easterly direction;
- (iii) the west side from its junction with the northern kerb line of Broadway East for a distance of 269 metres in a northerly direction;
- (vi) the east side from its junction with the north western kerb line of Brecklands for a distance of 56 metres in a northerly direction;
- (v) the east side from its junction with the southern kerb line of Wickersley Road for a distance of 64 metres in a southerly direction
- (iv) the west side from its junction with the northern kerb line of Wickersley Road for a distance of 42 metres in a northerly direction

Wickersley Road, Stag

- (i) the south side from its junction with the western kerb line of Stag Lane for a distance of 55 metres in a westerly direction;
- (ii) the south side from its junction with the eastern kerb line of Broom Lane for a distance of 56 metres in an easterly direction.

Schedule 2 Introduced "No Waiting At Any Time"

Herringthorpe Valley Road, Stag

- (i) the east side the Whole
- (ii) the west side from its junction with Worrygoose roundabout for a distance of 53 metres in a northerly direction
- (iii) the west side from its junction with the Mushroom roundabout to a point 180 metres north of the northern kerb line of Far Lane
- (iv) the west side from a point 124 metres north of the northern kerb line of Far Lane for a distance of 7.5 metres in a southerly direction
- (v) the west side from a point 52.5 metres north of the northern kerb line of Far Lane to a point 107.5 metres north of the northern kerb line of Wickersley Road
- (vi) from a point 42 metres north of the northern kerb line of Wickersley Road to a point 84 metres south of the southern kerb line of Wickersley Road

Schedule 3

"Prohibition Of Verge Parking"

Herringthorpe Valley Road – the west side from a point 53 metres north of Worrygoose roundabout to a point 84 metres south of the southern kerb line of Wickersley Road

The Order shall come into force of the 16 day of June 2008 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 (Amendment No.30) Order 2007
