
- 1. Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45 and 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:
- 2. The Order shall come into effect on the 29th day of September 2008 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) Traffic Regulations Consolidation) Order 2005 (Amendment No. 46) Order 2008
- 3. - (c) a ticket issued on payment of the charge shall be affixed on the vehicle and shall show the date and time of expiry on that ticket and shall be displayed in accordance with the following provisions:-
