THE ROTHERHAM BOROUGH COUNCIL (VARIOUS ROADS, ROTHERHAM)
(TRAFFIC REGULATIONS CONSOLIDATION) ORDER 2005
(AMENDMENT NO.50) ORDER 2008

1. Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 shall have effect as though:

(a) Items numbered (i) & (ii) headed Rotherham Road, Parkgate of Schedule No.1 No Waiting At Any Time there were deleted the following words:

(b) the following words were inserted as follows:-

items numbered (v) & (vi) headed Rawmarsh Road, St. Anns of Schedule No. 1

- (v) the west side from its junction with the projected western kerb line of St. Anns Road to its junction with Rotherham Road;
- (vi) the east side from its junction with the eastern kerb line of St. Anns Road to its junction with Rotherham Road;

(c) the following words were inserted as follows:-

items numbered (ii), (iii) & (iv) headed St. Anns Road, Eastwood of Schedule No. 1

St. Ann's Road, Eastwood

- (ii) the east side from its junction with the northern kerb line of Fitzwilliam Road for a distance of 215 metres in a north westerly direction;
- (iii) the east side from the southern kerb line of Rawmarsh Road to a point 47 metres south east of the northern kerb line of Erskine Road;
- (iv) the west side from its junction with the north western kerb line of Centenary Way to its junction with the southern kerb line of Rawmarsh Road

(d) the following words numbered (i) & (ii) headed Rotherham Road, Parkgate Schedule No.10 No Waiting Mon-Sat 8am-6pm were deleted:-


Rotherham Road, Parkgate

- (i) the east side from its junction with the northern kerb line of Midland Street to a point 17 metres south of the southern kerb line of Taylor Lane Roundabout;
- (ii) the west side from its junction with the north eastern kerb line of The Gateway to its junction with the southern kerb line of Taylors Lane roundabout;


