

**ROTHERHAM BOROUGH COUNCIL
THE ROTHERHAM BOROUGH COUNCIL (VARIOUS ROADS, ROTHERHAM)
(TRAFFIC REGULATIONS CONSOLIDATION) ORDER 2005
(AMENDMENT NO. 66) ORDER 2008**

1. Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 ("the 2005 Order") shall have effect as though there were included the following words:-

(1) Schedule 1 No Waiting At Any time headed Mansfield Road,
Wales (A618)

Mansfield Road, Wales (A618)

- (i) on the eastern side from the junction with the northern kerb line of the B6059 School Road for a distance of 156 metres in a northerly direction;
- (ii) on the western side from a point 34 metres north of the junction with the northern kerb line of Delves Lane for a distance of 219 metres in a southerly direction;

(2) Schedule 1 No Waiting at Any Time headed Delves Lane, Wales

Delves Lane, Wales

- (i) on the northern side from the junction with the western kerb line of the A618 Mansfield Road for a distance of 31 metres in a westerly direction;
- (ii) on the southern side from the junction with the western kerb line of the A618 Mansfield Road for a distance of 33 metres in a westerly direction;

(3) Schedule 1 No Waiting At Any Time at items (iv) and (v) headed
School Road, Wales

School Road, Wales (B6059)

- (iv) on the northern side from the junction with the eastern kerb line of the A618 Mansfield Road for a distance of 56 metres in an easterly direction;
- (v) on the southern side from the junction with the eastern kerb line of the A618 Mansfield Road for a distance of 172 metres in an easterly direction;

(4) Schedule 1 No Waiting At Any Time headed Almond Tree Road

Almond Tree Road, Wales

- (i) on the western side from the junction with the southern kerb line of the B6059 School Road for a distance of 17 metres in a southerly direction;
- (ii) on the eastern side from the junction with the southern kerb line of the B6059 School Road for a distance of 16 metres in a southerly direction;

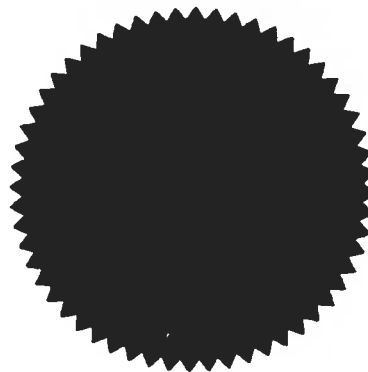
