

**ROTHERHAM BOROUGH COUNCIL
THE ROTHERHAM BOROUGH COUNCIL (VARIOUS ROADS, ROTHERHAM)
(TRAFFIC REGULATIONS CONSOLIDATION) ORDER 2005
(AMENDMENT NO. 67) ORDER 2008**

1. Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 ('the 2005 Order') shall have effect as though:-

- (1) There were deleted the following words from Schedule 1 No Waiting At Any Time at items (i) and (ii) headed Church Street, Wales

Church Street, Wales

- (i) the east side from its junction with the projected southern kerb line of Wales Road for a distance of 13 metres in a southerly direction;
- (ii) the west side from a point opposite the projected southern kerb line of Wales Road for a distance of 9 metres in a southerly direction;

and at items (i) and (ii) headed School Road, Wales

School Road, Wales

- (i) the northern side from its junction with the eastern kerb line of The Square for a distance of 40 metres in a generally westerly direction;
- (ii) the south side from its junction with the eastern kerb line of The Square for a distance of 45 metres in a westerly direction;

and there were included the following words at Schedule 1 No Waiting At Any Time at items (i) (ii) (iii) (iv) and (v) headed Church Street, Wales

Church Street, Wales

- (i) the western kerb line from the junction with the south western kerb line of School Road for a distance of 16 metres in a southerly direction;
- (ii) the eastern kerb line with the southern kerb line of Wales Road for a distance of 16 metres in a south westerly direction;
- (iii) the west side from the north side of Orchard Lane for a distance of 8 metres in a northerly direction;
- (vi) the west side from the southern junction with Orchard Lane for a distance of 10 metres in a southerly direction;
- (v) the east side from a point 21 metres north of the projected north side of Orchard Lane for a distance of 41 metres in a southerly direction;

- (2) there were included the following words at Schedule 1 No Waiting at Any Time at items (i) and (ii) headed Orchard Lane, Wales

Orchard Lane, Wales

- (i) the north side from the junction with the western kerb line of Church Street for a distance of 13 metres in a westerly direction;
- (ii) the south side from the junction with the projected western kerb line of Church Street for a distance of 16 metres in a westerly direction

- (3) there were included the following words at Schedule 1 No Waiting At Any Time at items (ii) and (iii) headed School Road, Wales

School Road, Wales (B6059)

- (ii) the south side 78 metres east of the projected eastern kerb line of School Close for a distance of 48 metres in a generally south easterly direction;
- (iii) the north side 78 metres east of the projected eastern kerb line of School Close for a distance of 56 metres in a generally south easterly direction;

- (4) There were included the following words at Schedule 1 No Waiting at Any Times at items (ii) &(iii) headed Wales Road Wales

Wales Road, Wales (B6059)


- (ii) the south side 22 metres west of the projected eastern kerb line of Hathaway Court for a distance of 46 metres to the junction of School Road and Wales Road, in a westerly direction;
- (iii) the north side 8 metres east of the projected eastern kerb line of Hathaway Court for a distance of 66 metres to the junction of School Road/Wales Road in a westerly direction;

3. The Rotherham Borough Council (School Road, Wales) (Prohibition of Waiting) Order 1989 (Amendment) Order 2003 is hereby revoked on the making of this Order.

4. The Order shall come into force on the 19th day of October 2009 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 (Amendment No.67) Order 2008
