

**THE ROTHERHAM BOROUGH COUNCIL
(ROTHERHAM TOWN CENTRE)
EXPERIMENTAL TRAFFIC ORDER 2010**

Rotherham Borough Council (hereinafter called "the Council") in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

PART 1 – GENERAL

Commencement and Citation

1. This Order shall come into operation on 7th June 2010 and may be cited as "The Rotherham Borough Council (Rotherham Town Centre) Experimental Traffic Order 2010.
2. In this order the Principle Order means The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 or a subsequent consolidation order to the Principle Order.
3. The Principle Order is hereby amended as follows:-

Schedule 1 - No Waiting At Any Time shall be amended to include the following words:-

Doncaster Gate, Rotherham Town Centre – north side from a point 41 metres east of the eastern kerb line of Percy Street for a distance of 24 metres in an easterly direction

Westgate, Rotherham Town Centre – item (v) of Schedule 1 shall be deleted " the west side from its junction with the southern kerb line of Main Street for a distance of 100 metres in a southerly direction" and replaced by the following words:

(v) the west side from its junction with the southern kerb line of Main Street for a distance of 31 metres in a southerly direction.

The following words shall be included at item (xi)
"the west side from a point 54 metres south of the southern kerb line of Main Street for a distance of 46 metres in a southerly direction".

Schedule 37 Part 7 - there shall be included the following words in the list of Schedules - Schedule 37 Part 7 – Disabled Person Parking Place (Monday – Saturday (inclusive) 8am-6pm) limited to 3 hours no return within 2 hours. There shall be included as Schedule 37 Part 7 the following words:-

"Wellgate, Rotherham Town Centre - from a point 85 metres south east of the southern kerb line of High Street for a distance of 35 metres in a south easterly direction"

Schedule 44 – the following roads or parts of road specified below will be removed from column 1 of Part 1 of Schedule 44 and included in Column 1 of Part 2 of Schedule 44 of the Principle Order

Domine Lane – the whole

Doncaster Gate, the whole

Mansfield Road – the whole

Moorgate Street – from its southern leg of The Crofts to its junction with the south eastern kerb line of High Street

Norfolk Street – the whole

Nottingham Street – the Whole

Percy Street – the Whole

Wharncliffe Street – the Whole

Schedule 55 – Hackney Carriage Places At Any Time shall be amended to include the following words:

“George Street – east side from a point 30 metres north of the northern kerb line of College Road for a distance of 15 metres in a northerly direction;”

Schedule 59 – Hackney Carriage Places 11pm to 6am All Days shall be amended to include the following words:-

“Main Street, Rotherham Town Centre

The north side from a point 22 metres east of the eastern kerb line of Market Street for a distance of 30 metres in an easterly direction;”


“Westgate, Rotherham Town Centre

The west side from a point 31 metres south of the southern kerb line of Main Street for a distance of 23 metres in a southerly direction;”

4. This Order shall continue in force for 18 months from the date the Order comes into operation but the Director of Planning and Regeneration or some person authorised by him or her may modify or suspend the operation of this Order or any provision contained in it in accordance with section 10 of the Act.
