

**ROTHERHAM BOROUGH COUNCIL
THE ROTHERHAM BOROUGH COUNCIL (VARIOUS ROADS, ROTHERHAM)
(TRAFFIC REGULATIONS CONSOLIDATION) ORDER 2005
(AMENDMENT NO.96) ORDER 2010**

1. Rotherham Borough Council in exercise of its powers under Section 1, 2 and 4 of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

2. The Rotherham Borough Council (Various Road, Rotherham) (Traffic Regulations Consolidation) Order 2005 ("the 2005 Order") shall have effect as though:

- (1) the following words were deleted from Schedule 12 "No Waiting Mon-Fri 8am-6pm"

Worrygopse Lane – north east side from its junction with the north western kerb line of Lathe Road for a distance of 274 metres in a south easterly direction

- (2) and there were included the following words at items (i) and (ii) of Schedule 12 "No Waiting Mon-Fri 8am-6pm" headed Worrygoose Lane, Whiston

- (i) north east side from its junction with the north western kerb line of Lathe Road for a distance of 224 metres in a south easterly direction to the eastern kerb line of Royds Avenue;
- (ii) north east side from a point 20 metres in a south easterly direction from its junction with the eastern kerb line of Royds Avenue for a distance of 38 metres in a south easterly direction to its junction with the western kerb line of Cow Rakes Lane

- (3) The following words were deleted in Schedule 19 "Prohibition of Verge Parking"

Worrygoose Lane, Whiston – both sides from its junction with Worrygoose Roundabout to its junction with the western kerb line of Cow Rakes Lane

(4) and there were included the following words at items (i) and (ii) of Schedule 19 "Prohibition of Verge Parking" headed Worrygoose Lane, Whiston:-

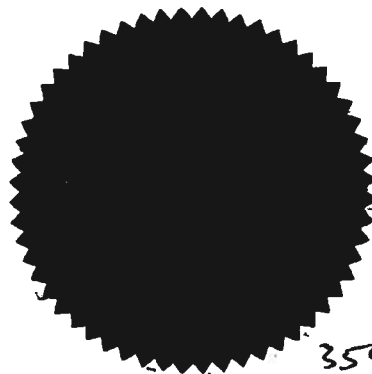
- (i) south west side from its junction with Worrygoose roundabout to its junction with the western kerb line of Cow Rakes Lane;
- (ii) north east side from its junction with Worrygoose roundabout to the eastern kerb line of Royds Avenue. Then from a point 20 metres in a south easterly direction from its junction with the eastern kerb line of Royds Avenue for a distance of 38 metres to its junction with the western kerb line of Cow Rakes Lane.

3, This Order is made on the 22nd July 2010 and shall come into force of the 26th day of July 2010 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 (Amendment No.96) Order 2010
