**THE ROTHERHAM BOROUGH COUNCIL
(VARIOUS ROADS, ROTHERHAM) (TRAFFIC REGULATIONS
CONSOLIDATION) ORDER 2005
(AMENDMENT NO. 104) ORDER 2010**

Rotherham Borough Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 45 and 46 and of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

PART 1 – GENERAL

Commencement and Citation

1. This Order is made on the 16th day of December 2010 and shall come into operation on 27th December 2010 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005 (Amendment No. 104) Order 2010.
2. This order reproduces and continues in force part of the provisions contained in the Rotherham Borough Council (Rotherham Town Centre) Experimental Order 2010.
3. In this order the Principle Order means The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2005.
4. The Principle Order is hereby amended as follows:-
 5. Schedule 1 - No Waiting At Any Time shall be amended and the following words shall be deleted:-

Westgate, Rotherham Town Centre

and there shall be included the following words :-

Doncaster Gate, Rotherham Town Centre

| (iv) north side from a point 41 metres east of the eastern kerb line of Percy Street for a distance of 24 metres in an easterly direction |

Westgate, Rotherham Town Centre at item (v) and item (xi)

(v) the west side from its junction with the southern kerb line of Main Street for a distance of 31 metres in a southerly direction.

(xi) the west side from a point 54 metres south of the southern kerb line of Main Street for a distance of 46 metres in a southerly direction".

6. The following roads or parts of road specified below shall be removed from column 1 of Part 1 of Schedule 44 of the Principle Order and included in Column 1 of Part 2 of Schedule 44:-

Domine Lane – the Whole

Doncaster Gate, the Whole

Mansfield Road – the Whole

Moorgate Street – from its southern leg of The Crofts to its junction with the southern eastern kerb line of High Street

Norfolk Street – the Whole

Nottingham Street – the Whole

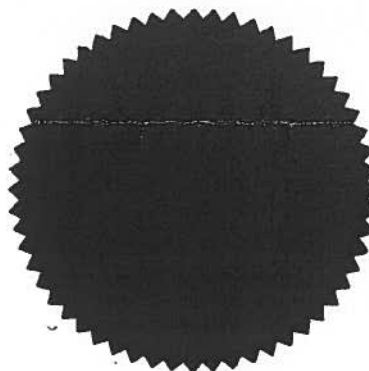
Percy Street – the Whole
