

**THE ROTHERHAM BOROUGH COUNCIL
(VARIOUS ROADS, ROTHERHAM)
(TRAFFIC REGULATION CONSOLIDATION) ORDER 2011
(AMENDMENT NO. 1) ORDER 2011**

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:-

(1) the following words were included in Schedule 1 "No Waiting At Any Time" of the 2011 Order under the headings and numbered items specified in Schedule 1 below:-

**Schedule 1
No Waiting At Any Time**

Blyth Road, Maltby

- (iv) north side from a point 52 metres west of the western extended kerb line of Millindale for a distance of 138 metres in an easterly direction;
- (v) south side from a point 38 metres west of the western extended kerb line of Foxcroft Meadows for a distance of 128 metres in an easterly direction.

Millindale, Maltby

Both sides from its junction with the northern extended kerb line of Blyth Road for a distance of 10 metres in a northerly direction

(2) the following words were deleted from Schedule 11 "No Waiting Mon-Sat 9am-6pm" of the 2011 Order specified in Schedule 2 below:-

Millindale, Maltby

- (i) the north east side from its junction with the north eastern kerb line of Blyth Road for a distance of 9 metres in a north easterly direction;
- (ii) the north west side from a point 10 metres south of its junction with the southern kerb line of High Street to its junction with the northern kerb line of Blyth Road.

(3) the following words were included in Schedule 11 "No Waiting Mon-Sat 9am-6pm" of the 2011 Order specified in Schedule 3 below:-

Millindale, Maltby

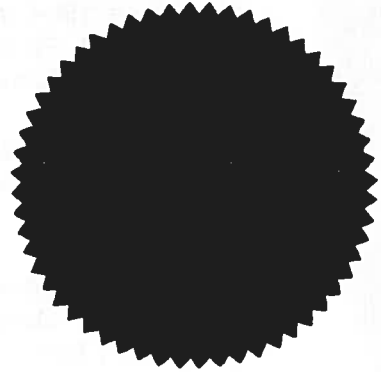
the western side from a point 10 metres north of its junction with the northern extended kerb line of Blyth Road to a point 10 metres south of its junction with the southern extended kerb line of High Street.

This Order is made on the 7th day of July 2011 and shall come into force on the 11th day of July 2011 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.1) Order 2011.
