

THE ROTHERHAM BOROUGH COUNCIL
(VARIOUS ROADS, ROTHERHAM)
(TRAFFIC REGULATION CONSOLIDATION) ORDER 2011
(AMENDMENT NO. 17) ORDER 2011

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as follows:-

- (i) there were deleted the following words at item (iv) of Schedule 1 of the 2011 Order under the heading "No Waiting At Any Time" Wellgate, Rotherham Town Centre

(iv) "the west side from a point 49 metres south of the southern kerb line of High Street for a distance of 34 metres in a southerly direction"

and there were included the following words at items (iv) and (xiii)

(iv) "the west side from a point 49 metres south of the southern kerb line of High Street for a distance of 32 metres in a southerly direction"

(xiii) "the west side from a point 114 metres south of the southern kerb line of High Street for a distance of 12 metres in a southerly direction"

- (ii) there were deleted the following words from Schedule 37 Part 1 of the 2011 Order under the heading Disabled Persons Parking Place all days, 24 hours Wellgate, Rotherham Town Centre:-

"the west side from a point 83 metres south east of the southern kerb line of High Street for a distance of 35 metres in a south easterly direction"

and there were included the following words

"the west side from a point 81 metres south east of the southern kerb line of High Street for a distance of 33 metres in a south easterly direction"

(ii) there were deleted the following words from Schedule 45 of the 2011 Order under the heading No Loading At Any Time – Wellgate, Rotherham Town Centre
"the south west side from a point 49 metres south east of the southern kerb line of High Street for a distance of 34 metres in a south easterly direction"

and there were included the following words
"the west side from a point 49 metres south of the southern kerb line of High Street for a distance of 32 metres in a southerly direction"

This Order is made on the 18th day of August 2011 and shall come into force on the 22nd day of August 2011 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.17) Order 2011.
