The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though the following words were deleted from "Schedule 1 No Waiting At Any Time" of the 2011 Order under the headings and at the numbered items specified in the Schedule below:-

A631 High Street, Maltby

(i) the north side from a point 176 metres west of its junction with the western kerb line of Grange Lane to a point 108 metres west of its junction with the western kerb line of Manor Road:

A631 Rotherham Road, Maltby

- (ii) the south side from a point 82 metres west of its junction with the western kerb line of Blyth Road to a point 94 metres west of its junction with the western kerb line of Carlyle Road:
- (iii) the north side from its junction with High Street for a distance of 126 metres in a westerly direction
- 3. The 2011 Order shall have effect as though the following words were included in "Schedule 1 No Waiting At Any Time" of the 2011 Order under the headings and at the numbered items specified in the Schedule below:-

Braithwell Road, Maltby

(i) the west side from its junction with the extended northern kerb line of A631 High Street for a distance of 124 metres in a northerly direction;

(ii) the east side from its junction with the extended northern kerb line of A631 High Street for a distance of 234 metres in a northerly the westerly direction.

Braithwell Road Service Road

(i) the south side from its junction with the western extended kerb line of Limesway for a distance of 10 metres in a westerly direction;

(ii) the north side from its junction with the western extended kerb line of Limesway for a distance of 10 metres in a westerly direction.

High Street, Maltby

(i) the north side from its junction with Rotherham Road to a point 176 metres west of its junction with the western kerb line of Grange Lane;

(viii) the south side from its junction with Rotherham Road to a point 98 metres west of its junction with the western kerb line of Carlyle Road

Limesway, Maltby

(i) the west side from its junction with the extended northern kerb line of Braithwell Road for a distance of 45 metres in a notherly direction;

(ii) the east side from its junction with the extended northern kerb line of Braithwell Road for a distance of 20 metres in a northerly direction.

Rotherham Road, Maltby

(ii) the south side from its junction with High Street to a point 162 metres west of the eastern kerb line of Blyth Road;

(iii) the north side from its junction with High Street to a point 234 metres west of the western extended kerb line of Braithwell Road.

4. The 2011 Order shall have effect as though the following words were deleted from "Schedule 11 No Waiting At Any Time" of the 2011 Order under the heading specified in the Schedule below:-

A631 High Street, Maltby

the north side from a point 75 metres west of the western kerb line of Braithwell Road for a distance of 220 metres in a north easterly direction
