SCHOOLS CLEARWAY(ROTHER VALLEY SOUTH) ORDER 2013

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

The effect of the order will be to prohibit vehicles from being able to stop or wait outside those school entrances on existing School Keep Clear markings in Rother Valley South as specified in the Schedule to this notice from Monday to Friday during the hours of 07:30am to 05:00pm.

under the heading specified in the Schedule below:-

SCHEDULE

No Stopping or Waiting - Monday to Friday during the hours of 07:30am to 05:00pm.

Anston Greenlands School - 1

Edinburgh Drive on the north-western kerb line from a point 92 metres north of the intersection between the extended eastern kerb line of Wellington Avenue and the north-western kerb line of Edinburgh Drive, for a distance of 25.56 metres in a northerly direction.

Anston Greenlands School - 2

Edinburgh Drive on the north-western kerb line from a point 154 metres north of the intersection between the extended eastern kerb line of Wellington Avenue and the north-western kerb line of Edinburgh Drive, for a distance of 43.56 metres in a northerly, then north-westerly direction.

Anston Greenlands School - 3

Edinburgh Drive on the north-western kerb line from a point 41 metres south west of the intersection between the southern channel line of Devonshire Drive and the extended north-western kerb line of Edinburgh Drive, for a distance of 25.56 metres in a south-westerly, then westerly direction.

Anston Brook Primary School

B6060 Ryton Road on the western kerb line from a point 78 metres south of the intersection between the projected southern kerb line of Sikes Road and the western channel of Ryton Road for a distance of 31.56 metres in a northerly direction.

Anston Park Infant School - 1

Park Avenue on the eastern kerb line from a point 6 metres south of the intersection between the projected southern kerb line of Buttermere Close and the eastern kerb line of Park Avenue for a distance of 25.56 metres in a northerly direction.

Anston Park Infant School - 2

Park Avenue on the eastern kerb line from a point 20 metres north-east of the intersection between the projected southern kerb line of Buttermere Close and the eastern kerb line of Park Avenue for a distance of 25.56 metres in a northerly direction.

Anston Park Junior School

Park Avenue on the south-eastern kerb line from a point 124 metres south-west of the intersection between the projected south-western kerb line of Beech Grove and the south-eastern channel line of Park Avenue for a distance of 43.56 metres in a south-westerly direction.

Harthill Primary School

Winney Hill on the western kerb line from a point 14 metres south of the intersection between projected southern kerb line of South Farm Avenue and the western kerb line of Winney Hill for a distance of 25.56 metres in a southerly direction

Harthill Primary School – 2

Winney Hill on the western kerb line from a point 39 metres south of the intersection between projected southern kerb line of South Farm Avenue and the western kerb line of Winney Hill for a distance of 25.56 metres in a southerly direction

Laughton All Saints Church of England Primary School

Laughton All Saints Church of England Primary School

High Street on the eastern kerb line from a point 33 metres south of the intersection between of the eastern kerb line of Brookhouse and northern channel of Brookhouse Lane for a distance of 31.56 metres in a southerly direction

Kiveton Park Meadows Primary School - 1

Storth Lane on the western kerb line from a point 34 metres north of the intersection between the projected northern kerb line of the residential section of Storth Lane and the western channel of Chestnut Avenue / Storth Lane for a distance of 25.56 metres in a northerly direction

Kiveton Park Meadows Primary School - 2

Storth Lane on the western kerb line from a point 60 metres north of the intersection between the projected northern kerb line of residential section of Storth Lane and the western channel of Chestnut Avenue / Storth Lane for a distance of 25.56 metres in a northerly direction

Kiveton Park Meadows Primary School - 3

Storth Lane on the western kerb line from a point 134 metres north of the intersection between the projected northern kerb line of residential section of Storth Lane and the western channel of Chestnut Avenue / Storth Lane for a distance of 37.56 metres in a southerly direction

Woodsetts Primary School

Wellfield Crescent on the northern kerb line from a point 50 metres north-west of the intersection between the projected northern kerb line of Wellfield Crescent and the northern channel of Scholey Avenue for a distance of 37.56 metres in a westerly direction

This Order is made on the 17th day of October 2013 and shall come into force on the 21st day of October 2013 and may be cited as "The Rotherham Borough Council SCHOOLS CLEARWAY(ROTHERVALLEY SOUTH) Order 2013.
