No waiting at any time
Kiveton Lane / The Pastures, Todwick, Sheffield

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (the 2011 Order) shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting At Any Time

Kiveton Lane

Kiveton Lane on the western side from a point 19 metres south of the intersection between the southern kerb line of The Pastures and the western kerb line of Kiveton Lane for a distance of 161 metres in a northerly direction.

Kiveton Lane on the eastern side from a point 19 metres south of the intersection between the southern kerb line of The Pastures and the western kerb line of Kiveton Lane for a distance of 146 metres in a northerly direction.

The Pastures

The Pastures on the northern side from the intersection between the northern kerb line of The Pastures and the western kerb line of Kiveton Lane for a distance of 29 metres in a westerly direction.

The Pastures on the southern side from the intersection between the southern kerb line of The Pastures and the western kerb line of Kiveton Lane for a distance of 46 metres in a westerly direction.

This Order is made on the 13th. March 2014 and shall come into force on the 17th. March 2014 and may be cited as "The Rotherham Borough Council (Kiveton Lane / The Pastures, Todwick, Sheffield) (Traffic Regulation Consolidation) Order 2011 (Amendment No.57) Order 2014.
