Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule No 21 of the 2011 Order "Waiting Limited to 30 minutes, no return within 90 minutes" of the 2011 Order
- (ii) Schedule 33 "Waiting Limited to 1 hour, no return within 2 hours" was included in the 2011 Order and the words specified in Schedule 2 hereto were included in Schedule 33 of the 2011 Order

Schedule No 21

Waiting Limited to 30 minutes, no return within 90 minutes

Station Road B6059, Kiveton Park

the south side from a point 10 metres south-west of the south western kerb line of Hard Lane for a distance of 47 metres in a north westerly direction

Schedule 2

To be introduced:

Schedule No 33

Waiting Limited to 1 hour, no return within 2 hours

Station Road B6059, Kiveton Park

the south side from a point 10 metres west of the south western kerb line of Hard Lane for a distance of 47 metres in a north westerly direction
