Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 37 Part 6 of the 2011 Order "Disabled Persons Parking Place All days 24 hours (limited to 3 hours, no return within 2 hours)" of the 2011 Order under the headings and numbered items specified therein
- (ii) the words specified in Schedule 2 hereto were included in Schedule 37 Part 1 of the 2011 Order "Disabled Persons Parking Place All days 24hrs" under the headings and numbered items specified therein
- (iii) the words specified in Schedule 3 hereto were included in Schedule 37 Part 2 of the 2011 Order "Disabled Persons Parking Place All days 9am-4pm" under the headings and numbered items specified therein
