Drummond Street, Drummond Street/Wharncliffe Street Service Road,
Effingham Street, Water Street, Rotherham Drummond Street, Effingham
Square, Nottingham Street and Tesco Service Road Rotherham Town Centre

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1

Schedule 1 No Waiting At Any Time

Drummond Street, Rotherham Town Centre

(i)	both sides from its junction with the south eastern kerb line of Eastwood Lane for a distance of 4 metres in a south easterly direction;
(ii)	the north east side from its junction with Wharncliffe Street to a point 40 metres north west of its junction with Effingham Square;
(iii)	the south west side from its junction with Wharncliffe Street to its junction with the south eastern kerb line of Water Street.

Drummond Street/Wharncliffe Street Service Road, Rotherham Town Centre

(i)	the north east side – the whole;
(ii)	the south west side from a point 37 metres north west of its junction with the north eastern kerb line of Eastwood Lane for a distance of 9

metres.

Effingham Square, Rotherham Town Centre

- (i) the north west side from its junction with the south western kerb line of Drummond Street for a distance of 10 metres in a south westerly direction;
- (ii) the north west side from a point 34 metres south west of its junction with the south eastern kerb line of Drummond Street to its junction with the south eastern kerb line of Water Street;
- (iii) the south west side from its junction with the south western kerb line of Drummond Street for a distance of 95 metres in a south westerly direction.

Water Street, Rotherham Town Centre

- (i) the north west side from its junction with the projected south western kerb line of the northern part of Drummond Street in a south westerly then south easterly direction to its junction with Frederick Street;
- (ii) the north west side from its junction with the south western kerb line of the northern part of Drummond Street in a south westerly then south easterly direction to its junction with Frederick Street.

Drummond Street Service Road, Rotherham Town Centre

- (i) the north east side – the whole;
- (ii) the south west side from a point 37 metres north west of its junction with the north eastern kerb line of Eastwood Lane for a distance of 9 metres.
- (iii) the south west side from a point 67 metres north west of its junction with the north eastern kerb line of Eastwood Lane to its junction with Drummond Street

Effingham Square

- (i) the south east side from its junction with Frederick Street for a distance of 20 metres in a north easterly direction
- (ii) the south east side from a point 46 metres north east of its junction with Frederick street for a distance of 3metres in a north easterly direction.
