No waiting at any time
Tickhill Road and Strauss Crescent Maltby Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Tickhill Road, Maltby

The north east side from a point 55.00 metres east of its junction with the eastern kerb line of Hamilton Road for a distance of 72.00 metres in an easterly direction (to its junction with the western kerblines of Strauss Crescent)

Schedule 2

Schedule 1 No Waiting at Any Time

Tickhill Road, Maltby

The north east side from a point 55.00 metres east of its junction with the eastern kerb line of Hamilton Road for a distance of 81.00 metres in an

easterly direction (to its junction with the western kerbline of Strauss Crescent)

Tickhill Road, Maltby

Southern kerbline from a point 25.00 metres from the extended Western kerbline of Beresford Road to a distance of 34.00 metres in a Westerly direction (to its junction with the eastern kerbline of Strauss Crescent)

Strauss Crescent, Maltby

Northern kerbline from a point 12.00 metres from the extended Western kerbline of the Western school entrance for a distance of 10.00 metres in an Easterly direction.

Northern kerbline from a point 6.00 metres from the extended Western kerbline of the Western school entrance to a distance of 27.00 metres in a Westerly direction (to its junction with the southern kerbline of Tickhill Road)

This Order is made on the 10th. October 2013 and shall come into force on the 14th. October 2013 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.45) Order 2013.
