- (v) north east side from the north western kerb line of the Hospice entrance for a distance of 25 metres in a north westerly direction
- (vi) north east side from the south eastern kerb line of the Hospice entrance for a distance of 180 metres in a south easterly direction
- (vii) south west side from the north western kerb line of Broomfield Grove for a distance of 20 metres in a north westerly direction
- (viii) south west side from the south eastern kerb line of Broomfield Grove for a distance of 20 metres in a south easterly direction
- (ix) south west side from the north western kerb line of the north western junction of Broom Crescent for a distance of 26 metres in a north westerly direction
- (x) south west side from the south eastern kerb line of the north western

- junction of Broom Crescent for a distance of 15 metres in a south easterly direction
- (xi) south west side from the north western kerb line of south eastern junction of Broom Crescent for a distance of 18 metres in a north westerly direction
- (xii) south west side from the south eastern kerb line of the south eastern junction of Broom Crescent for a distance of 21 metres in a south easterly direction

Boswell Street, Broom

Broomfield Grove, Broom

Both sides from the junction with Broom Road for a distance of 10 metres in a south westerly direction

Broom Crescent, Broom (north western junction with Broom Road)

Broom Crescent, Broom (south eastern junction with Broom Road)

Both sides from the junction with Broom Road for a distance of 10 metres in a south westerly direction
