  - (iii) Schedule 34 Part 4 'Waiting limited to 2hrs no return within 4hrs Monday to Saturday 9am 6pm' was included in the 2011 Order and the words specified in Schedule 3 hereto were included in Schedule 34 Part 4 of the 2011 Order
