Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting At Any Time

B6059 Sheffield Road South Anston

On both sides of the B6059 Sheffield Road from a point 414 metres west of where the southern kerb line of the B6059 Sheffield Road intersects with the south-western channel line of the A57 Worksop Road for a distance of 160 metres in a north-westerly direction,.

Hawthorne Avenue South Anston

- (i) On the eastern side of Hawthorne Avenue from the tangent point of Hawthorne Avenue and the B6059 Sheffield Road for a distance of 17 metres in a southerly direction
- (ii) On the western side of Hawthorne Avenue from the tangent point of Hawthorne Avenue and the B6059 Sheffield Road for a distance of 19 metres in a southerly direction.

Hillcrest Drive South Anston

- (i) On the southern side of Hillcrest Drive from the tangent point of Hillcrest Drive and the B6059 Sheffield Road for a distance of 10 metres in a westerly direction
- (ii) On the north-western side of Hillcrest Drive from the tangent point of Hillcrest Drive and the B6059 Sheffield Road for a distance of 17 metres in a south / south-westerly direction.

This Order is made on the 31st. October 2013 and shall come into force on the 4th. November 2013 and may be cited as "The Rotherham Borough Council (B6059 Sheffield Road Hawthorne Avenue and Hillcrest Drive South Anston Sheffield) (Traffic Regulation Consolidation) Order 2011 (Amendment No.39) Order 2013.
