Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Part (i) of Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" and replaced by the words specified in Part (ii) of Schedule 1 hereto under the headings and numbered items specified therein
- (ii) the words specified in Schedule 2 hereto were included in Schedule 45 of the 2011 Order "No Loading At Any Time" under the headings and numbered items specified therein
- (iii) the words specified in Schedule 3 hereto were included in Schedule 53 of the 2011 Order "Loading/Unloading Mon-Sat 8am-6pm" under the headings and numbered items specified therein

Schedule 1

Schedule 1 No Waiting at Any Time

To be revoked

(i) Wellgate, Rotherham, Town Centre – the north east side from the southern kerb line of Doncaster Gate to a point 50 Metres north west of the north western kerb line of Clifton Terrace

To be introduced

(ii) Wellgate, Rotherham, Town Centre – the north east side from the southern kerb line of Doncaster Gate to a point 22 metres north west of the north western kerb line of Clifton Terrace.

Schedule 2
Schedule 45 No Loading At Any Time

Wellgate, Rotherham Town Centre – the north east side from a point 40 metres north west of the northern kerb line of Clifton Terrace for a distance of 40 metres in a north westerly direction

Schedule 3
Schedule 53 Loading/Unloading Mon-Sat 8am-6pm

Wellgate, Rotherham Town Centre – the north east side from a point 24 metres north west of the northern kerb line of Clifton Terrace for a distance of 13 metres in a north westerly direction

This Order is made on the 26th. September 2013 and shall come into force on the 30th. September 2013 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.24) Order 2013.
