No Waiting At Any Time
Doncaster Road, Town Centre/Clifton Doncaster Road, Eastwood and
Cranworth Road, Eastwood Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1

To be revoked

Schedule 1 No Waiting at Any Time

Doncaster Road, Rotherham Town Centre

- (i) the north-west side from its junction with the north eastern kerbline of Catherine Street to its junction with the south western kerbline of Wharncliffe Street
- (ii) the south-east side from its junction with the south western kerbline of Clifton Lane to its junction with the north eastern kerbline of Chatham Street

Doncaster Road, Clifton (ii)

The south west side from a point 13 metres north east of the north western kerb line of Middle Lane for a distance of 230 metres in a south-westerly direction

Doncaster Road, Eastwood

The north-west side from a point 57 metres south west of the extended kerb line of St Anns Road to a point 210 metres north east of the extended kerb line of Cottenham Road

Schedule 2

Schedule 1 No Waiting at Any Time

Doncaster Road, Town Centre / Clifton

- (i) The north-west side from its junction with the north eastern kerbline of Catherine Street to a point 10 metres north east of the extended eastern kerb line of Cranworth Road
- (ii) The south-east side from the north eastern kerbline of Chatham Street to a point 103 metres north east of the projected north eastern kerb line of Middle Lane

Doncaster Road, Clifton

The south east side from the tangent point with the south western side of Old Garden Drive for a distance of 34 metres in a south-westerly direction

Cranworth Road, Eastwood

Both sides from the channel line of Doncaster Road for a distance of 10 metres in a northerly direction

This Order is made on the 13th. November 2014 and shall come into force on the 17th. November 2014 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.67) Order 2014.
