Ryton Road and Sheffield Road South Anston Sheffield

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

B6059 Sheffield Road South Anston

The north side from a point 40 metres west of its junction with the western kerb line of Yeomans Way to a point 72 metres east of the eastern kerblines of Yeomans Way

Schedule 2

To be introduced

Schedule 1 No Waiting at Any Time

B6059 Sheffield Road South Anston

(i)	The northern side from a point 40 metres west of its junction with the western kerb line of Yeomans Way to its junction with Ryton Road
(ii)	The northern side from its junction with Ryton Road for a distance of 10 metres in an easterly direction.

B6060 Ryton Road South Anston

(i)	West side from its junction with Sheffield Road for a distance of 20 metres in a northerly direction.
(ii)	East side from its junction with Sheffield Road for a distance of 34 metres in a northerly direction.

This Order is made on the 14th. August 2014 and shall come into force on the 18th. August 2014 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.63) Order 2014.
