Residents Parking
Wellgate Mount and Clifton Bank Rotherham Town Centre

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 35 Part 2 of the 2011 Order "Residents Parking Space Mon-Sat 9am-4pm" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 35 Part 5 of the 2011 Order "Residents Parking Only Mon-Sat 9am-7pm"

Schedule 1

Schedule 35 part 2 Residents Parking Space Mon-Sat 9am-4pm

- i. Clifton Bank, Rotherham, the north-west side, from a point 146 metres from the north eastern kerbline of its junction with Wellgate for a distance of 14 metres in a north easterly direction
- ii. Clifton Bank, Rotherham, the north-west side, from a point 84 metres from the north eastern kerbline of its junction with Wellgate for a distance of 55 metres in a north easterly direction
- iii. Clifton Bank, Rotherham Town Centre, the north-west side, from a point 49 metres from the north eastern kerbline of its junction with Wellgate for a distance of 19 metres, in a northeasterly direction.

- iv. Wellgate Mount, Rotherham, the north-west side, from a point 68 metres from the north eastern kerbline of Wellgate for a distance of 92 metres in a north easterly direction.
- v. Wellgate Mount, Rotherham, the south-east side, from a point 10 metres north east of the north eastern kerbline of Wellgate for a distance of 42 metres in a north easterly direction.

Schedule 2

Schedule 35 Part 5 Residents Parking Only Mon – Sat 9:00 – 19:00

- i. Clifton Bank, the north-west side from a point 49 metres from its junction with Wellgate for a distance of 19 metres in a north-easterly direction
- ii. Clifton Bank, the north-west side from a point 84 metres from its junction with Wellgate for a distance of 50 metres in a north-easterly direction
- iii. Clifton Bank, the north-west side from a point 142 metres from its junction with Wellgate for a distance of 17 metres in a north-easterly direction
- iv. Wellgate Mount, the north-west side from a point 68 metres from its junction with Wellgate for a distance of 91 metres in a north-easterly direction
- v. Wellgate Mount, the south-east side from a point 10 metres from its junction with Wellgate for a distance of 42 metres in a north-easterly direction

This Order is made on the 10th. October 2013 and shall come into force on the 14th. October 2013 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.33) Order 2013.
