No waiting Mon – Fri 8am-6pm

Little Haynooking Lane Lilly Hall Road and Braithwell Road Maltby Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 12 of the 2011 Order "No Waiting Mon – Fri 8am-6pm" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 12 of the 2011 Order "No Waiting Mon – Fri 8am-6pm"

Schedule 1

To be revoked

Schedule No 12

'No waiting Mon – Fri 8am-6pm' restrictions

Lilly Hall Road Maltby

The north side from its junction with the eastern kerb line of Little Haynooking Lane for a distance of 53 metres in an easterly direction.

Schedule 2

To be introduced

Schedule No 12

'No waiting Mon – Fri 8am-6pm' restrictions

Little Haynooking Lane Maltby.

Both sides - from the junction with Lilly Hall Road, in a northerly direction for a distance of 15 metres.

Lilly Hall Road, Maltby

North Side – Commencing 15m west of the projected back of the western footway of Little Haynooking Lane to its junction with Braithwell Road.

Braithwell Road, (Western Service Road) Maltby

Both sides – from its junction with Lilly Hall Road for a distance of 15 metres in a northerly direction

This Order is made on the 14th. May 2015 and shall come into force on the 18th. May 2015 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.87) Order 2015.
