**Sheffield Road Canklow Rotherham**

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 44 Part 3 of the 2011 Order Pay and Display 8am-6pm – Monday to Saturday (inclusive) - Maximum stay 10 hours under the headings specified therein
- (ii) the words specified in Schedule 2 hereto were included in Schedule 27 of the 2011 Order Waiting Limited to 1 hour no return within 3 hours Mon-Sat 8am-6pm under the headings specified therein

**Pay and Display Zone  
8am-6pm – Monday to Saturday (inclusive) – Maximum stay 10 hours**

Sheffield Road from its junction with Westgate to its junction with the North Eastern kerblineline of Old Sheffield Road – Wholly within the limits of the parking bay.

Schedule 2

**To be introduced  
Schedule No 27**

**Waiting Limited to 1 hour no return within 3 hours Mon-Sat 8am-6pm**

Sheffield Road from its junction with Westgate to its junction with the North Eastern kerbline of Old Sheffield Road – Wholly within the limits of the parking bay.

This Order is made on the 21<sup>st</sup>. August 2014 and shall come into force on the 25<sup>th</sup>. August 2014 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.75) Order 2014.
