Roads around Masbrough Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

- 2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have the following effect:
- to prohibit waiting at any time by any vehicle on those lengths of road specified in Schedule 1
- revoke the existing waiting restrictions specified in Schedule 1 Princes
 Street, St. Bede's Road and Victoria Street and replace with those specified in Schedule 1
- to prohibit waiting Monday to Saturday 8am-6pm by any vehicles on those lengths of road specified in Schedule 10
- revoke the existing No Waiting Monday to Saturday 8am-6pm specified in Schedule 10 Station Road and replace with those specified in Schedule 10 Station Road (i), (ii) & (iii)
- to limit waiting to a maximum stay of 2 hours with no return in 2 hours
 9am-4pm Monday-Friday by any vehicle on those lengths of road specified in
 Schedule 34 Part 4
- to limit waiting to a maximum stay of 3 hours with no return in 3 hours
 9am-4pm Monday-Friday by any vehicle on those lengths of road specified in
 Schedule 34 Part 5
- revoke the existing No Waiting 11pm-midnight and midnight-6am specified in Schedule 5 Masbrough Street

 revoke the existing Hackney Carriage Places 11pm-midnight and midnight-6am specified in Schedule 59 Masbrough Street

Schedule 1 No waiting at any time

Albert Street

- (i) Both sides from its junction with the northern kerbline of Station Road for a distance of 5 metres in a northerly direction.
- (ii) the east side from a point 10 metres south of its junction with the southern kerbline of St. Bede's Road for a distance of 30 metres in a northerly direction.
- (iii) the west side from a point 78 metres north of its junction with the northern kerbline of Station Road for a distance of 16 metres in a northerly direction.

Coronation Bridge

(i) both sides – the whole

Kimberworth Road

(i) the south east side from its junction with Ferham Road for a distance of 16 metres in a northerly then easterly direction

Masbrough Street

- the north side from its junction with the projected eastern kerbline of Victoria Street for a distance of 10 metres in an easterly direction
- (ii) the north side from a point 84 metres south east of its junction with the eastern kerbline of Princes Street for a distance of 27 metres in an easterly then southerly and then westerly direction
- (iii) the south side from a point 8 metres east of its junction with the eastern kerb line of Lyme Street to a point 51 metres west of its junction with Providence Street
- (iv) the north side from a point 8 metres east of the projected eastern kerbline of Lyme Street to a point 22 metres west of its junction with the projected southern kerbline of Station Road

- (i) the west side from its junction with the northern kerbline of St. Bede's Road for a distance of 20 metres in a northerly direction.
- (ii) The east side from its junction with the north eastern kerbline for a distance of 5 metres in a northerly direction.

Princes Street

REVOCATION

Eastern side from its junction with the southern kerbline of College Road for a distance of 18 metres in a southerly direction

West side from its junction with the southern kerbline of College Road for a distance of 10 metres in a southerly direction

INTRODUCTION

- (i) The east side from its junction with the southern kerbline of College Road to its junction with the northern kerbline of Station Road
- (ii) The west side from its junction with the southern kerbline of College Road for a distance of 22 metres in a southerly direction
- (iii) The west side from a point 77 metres south of its junction with the southern kerbline of College Road for a distance of 38 metres in a southerly direction
- (iv) The east side from its junction with the southern kerbline of Station Road for a distance of 10 metres in a southerly direction
- (v) The east side from a point 62 metres south of its junction with the southern kerbline of Station Road for a distance of 13 metres in a south easterly direction

Providence Street

(i) Both sides from its junction with the southern kerbline of Masbrough Street for a distance of 10 metres in a southerly direction

Robert Street

- (i) The north side from its junction with the western kerbline of Victoria Street for a distance of 62 metres in a westerly then southerly direction
- (ii) The south side from its junction with the western kerbline of Victoria Street for a distance of 10 metres in a westerly direction

Station Road

- (i) The south side from a point 102 metres north west of its junction with the projected northern kerbline of Masbrough Street for a distance of 15 metres in a north westerly direction
- (ii) The south side from a point 151 metres north west of its junction with the projected northern kerbline of Masbrough Street for a distance of 14 metres in a north westerly direction
- (iii) The south side from a point 8 metres south east of the projected eastern kerbline of Victoria Street for a distance of 24 metres in a north westerly direction

- (iv) The south side from its junction with the south eastern kerbline of Princes Street for a distance of 14 metres in a south easterly direction.
- (v) The north side from its junction with the north eastern kerbline of Princes Street for a distance of 11 metres in a south easterly direction
- (vi) The north side from a point 10 metres north west of its junction with the western kerbline of Albert Street for a distance of 27 metres in a south easterly direction

St. Bede's Road

REVOCATION

The eastern, northern and south eastern side from a point 44 metres north of its junction with the northern kerbline of Station Road for a distance of 78 metres in a northerly, north westerly and then north easterly direction.

INTRODUCTION

- (i) The east and northern side the whole
- (ii) The west side from its junction with the northern kerbline of Station Road for a distance of 10 metres in a northerly direction.
- (iii) The west side from a point 59 metres north of its junction with the northern kerbline of Station Road for a distance of 5 metres in a northerly then westerly direction.
- (iv) The west side from a point 82 metres north of its junction with the northern kerbline of Station Road for a distance of 8 metres in a westerly direction.
- (v) The south side from its junction with the eastern kerbline of Albert Street for a distance of 6 metres in an easterly direction.
- (vi) The south side from a point 52 metres east of the eastern kerbline of Albert Street for a distance of 6 metres in an easterly then southerly direction.

Both sides from its junction with the southern kerbline of College Road for a distance of 14 metres in a southerly direction

- (vi) The west side from its junction with the northern kerbline of Masbrough Street for a distance of 16 metres in a northerly direction
