No Waiting at Any Time
West Bawtry Road Canklow Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (the 2011 Order) shall have effect as though the following words were included in Schedule 1 'No Waiting At Any Time' of the 2011 Order under the heading specified in the Schedule below:-

Schedule 1 'No Waiting at Any Time'

West Bawtry Road, Canklow

1.

The Northern kerbline from the extended Eastern kerbline of West Bawtry Road, for a distance 19.00 metres in a Easterly direction.

2.

The Eastern kerbline of West Bawtry Road (service road) from the extended northern kerbline of car park entrance, for a distance of 25.00 metres in a Southerly direction.

3.

The Northern kerbline of West Bawtry Road (service road) from the extended Eastern kerbline of West Bawtry Road for a distance of 12.00 metres in an Easterly direction.

4.

The Southern kerbline of private entrance on West Bawtry Road (service road), from the extended Eastern kerbline of West Bawtry Road (service road) for a distance of 4.00 metres in a Easterly direction.

5.

The Eastern kerbline of West Bawtry Road (service road) from the extended southern kerbline of private entrance on West Bawtry Road, for a distance of 14.00 metres in a southerly direction.

6.

Northern kerbline of private entrance on West Bawtry Road (service road) from the extended Eastern kerbline of West Bawtry Road (service road) for a distance of 4.00 metres in an Easterly direction.

7.

Southern kerbline of private entrance on West Bawtry Road (service road) for a distance of 7.00 metres in a Southerly direction.

8.

Southern kerbline of West Bawtry Road (service road), from the extended Eastern kerbline of West Bawtry Road for a distance of 14.00m in a Northerly direction.

9.

Western kerbline of West Bawtry Road (service road), from the extended Northern kerbline of West Bawtry Road for a distance of 30.00m in a Southerly direction.

10.

Northern kerbline of West Bawtry Road from the extended Western kerbline of West Bawtry Road (service road) for a distance of 30.00m in a Southwesterly direction.

This Order is made on the 17th. day of April 2014 and shall come into force on the 21st. day of April 2014 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.43) Order 2013.
