(AMENDMENT NO. 84) ORDER 2015

Prohibition of Waiting – Northfield Lane, Warde Aldam Crescent and Warren  
Road, Wickersley, Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, and 4, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though the following words were included in "Schedule 1 No Waiting At Any Time" of the 2011 Order under the headings specified in the Schedule below:-

Schedule

**Northfield Lane, Wickersley.**

- i. 

North-eastern kerbline from the extended North-western kerbline of Warren Road, in a North-westerly direction for a distance of 33.00 metres.
- ii. 

South-western kerbline from the extended South-eastern kerbline of Warde Aldam Crescent, in a South-easterly direction for a distance of 17.00 metres.
- iii. 

South-western kerbline from the extended North-western kerbline of Warde Aldam Crescent, in a North-westerly direction for a distance of 20.00 metres.

**Warren Road, Wickersley.**

Both sides from the extended North-western kerbline of Northfield Lane, in a North-easterly direction for a distance of 20.00 metres.

**Warde Aldam Crescent, Wickersley.**

Both sides from the extended South-eastern kerbline of Northfield Lane, in a South-westerly direction for a distance of 30.00 metres.

This Order is made on the 28<sup>th</sup>. day of May 2015 and shall come into force on the 1<sup>st</sup>. day of June 2015 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.84) Order 2015.
