No waiting at any time
St. Mary's Drive and Tristford Close Catcliffe Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting at Any Time

St Mary's Drive Catcliffe

i

Northern Kerbline from the extended Western Kerbline of Rotherham Road for a distance of 43m in a Westerly direction

ii

Southern Kerbline from the extended Western Kerbline of Rotherham Road for a distance of 27m in a Westerly direction

iii

Southern Kerbline from the extended Eastern Kerbline of Tristford Close for a distance of 13m in an Easterly direction.

- iv SouthernKerbline from the extended Western Kerbline of Tristford Close for a distance of 10m in a Westerly direction

Tristford Close, Catcliffe

- i Eastern kerbline from the extended Southern kerbline of St Mary's Drive for a distance of 10.00m in a Southerly direction.

- ii Western kerbline from the extended Southern kerbline of St Mary's Drive for a distance of 32.00m in a Southerly direction.

This Order is made on the 1st. June 2017 and shall come into force on the 5th. June 2017 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.139) Order 2017.
