Various roads at Wickersley Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"
- (iii) the words specified in Schedule 3 hereto were included in Schedule 14 part 2 of the 2011 Order "No Waiting all days 9am-5pm"
- (iv) the words specified in Schedule 4 hereto were included in Schedule 28 of the 2011 Order "Waiting limited to 2 hours no return within 2 hours Mon-Sat 8am-6pm"
- (v) the words specified in Schedule 5 hereto were included in Schedule 36 part 1 of the 2011 Order "Waiting limited to 4 hours no return within 2 hours Mon-Sat 8am-6pm"

Bawtry Road Service Road

- i the north side from a point 15 metres west of its junction with the western kerb line of The Grove to a point 18 metres east of its junction with the eastern kerblines of The Grove.

The Bawtry Road Service Road

- i The north west side from the north eastern kerb line of Chevril Court to south western kerb line of Rosemary Road.
- ii The north western side from the north eastern kerb line of Rosemary Road for a distance of 5 metres in a north easterly direction.
- iii The north western side from the south western kerb line of Green Lane for a distance of 10 metres in a south westerly direction.
- iv The north west side from the north eastern kerb line of Green Lane for a distance of 5 metres in a north easterly direction.
- v The north west side from a point 23 metres north east of the north eastern kerb line of Green Lane for a distance of 12 metres a north easterly direction.
- vi The north side from the western kerblines of The Grove for a distance of 33 metres in a westerly direction.
- vii The north side from eastern kerb line of The Grove for a distance of 27 metres in an easterly direction.
- viii The east side from its junction with the northern kerblines for a distance of 3.0m in a southerly direction.
- ix The southern kerblines from its junction with the eastern kerblines for a distance of 14 metres in a westerly direction.
- x The west side from its junction with Bawtry road for a distance of 26m in a northerly then westerly then south westerly direction.

- xi The east side from its junction with Bawtry Road for a distance of 30m in northerly then easterly then south easterly direction.
- xii The south east side from its junction with south western kerbline of Chevril Court for a distance a distance of 147 metres in a north easterly direction.

Chevril Court

- i Both sides from the junction with the north western kerbline of the Bawtry Road Service Road, for a distance of 27 metres in a north westerly direction

Rosemary Road

- i Both sides the north western kerbline of the Bawtry Road Service Road, for a distance of 14 metres in a north westerly direction

Green Lane

- i Both sides the north western kerbline of the Bawtry Road Service Road, for a distance of 10 metres in a north westerly direction

The Grove

- i The west side from a point 15 metres north of its junction with the northern kerbline of the Bawtry Road Service Road to its termination.
- ii the east side from a point 33 metres north of its junction with the Bawtry Road Service Road to its termination.

The Bawtry Road Service Road

- i The north west side from a point 5 metres north east of the north eastern kerbline of Rosemary Road to a point 10 metres south west of the south western kerbline of Green lane.
- ii The north west side from a point 5 metres north east of the north eastern kerbline of Green Lane for a distance of 18 metres in a north easterly direction.
- iii The north west side from a point 35 metres north east of the north eastern kerb line of Green Lane for a distance of 6 metres in a north easterly direction.
- iv The south east side from a point 147 metres north east of the south western kerbline of Chevril Court for a distance of 20 metres in a north easterly direction.

Bawtry Road Service Road

- i The south side from a point 14 metres west of its termination for a distance of 40 metres in a westerly direction.
