No waiting at any time A618 Pleasley Road, Reservoir Road and Ulley Lane, Ulley, Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

- 2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though:
  - (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting at any time" of the 2011 Order
  - (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

# Schedule No 1 No waiting at any time

## Reservoir Road

- (i) South east and south west and north west a length of 70 metres commencing at and proceeding in a south easterly and then south westerly direction from the centre point of the south westerly parapet of the bridge which passes over Ulley Reservoir and a length of 90 metres commencing at and proceeding in a north westerly and then south westerly direction from that centre point;
- (ii) North east side a length of 12 metres commencing at and proceeding in a south easterly direction from the centre point of the north easterly parapet of the bridge which passes over Ulley Reservoir and a length of 8 metres commencing at and proceeding in a north westerly direction from that centre point.

## Schedule 2

# Schedule No 1 No waiting At Any Time

## A618 Pleasley Road

i Both sides from a point 497 metres north of the northern kerb line of Treeton Lane for a distance of 312 metres in a northerly direction.

### Reservoir Road

- i both sides from the centre point of the Bridge for a distance of 275metres in a north westerly, westerly then north westerly direction.
- ii both sides from the centre point of the bridge for a distance of 450 metres in a south easterly, then south westerly, and the south easterly direction.

## **Ulley Lane**

- i the north side from a point 395 metres east of is junction with the A618 Pleasley Road, for a distance of 51 metres in a north easterly direction.
- ii The north side from a point 469 metres east of its junction with the A618 Pleasley Road for a distance of 109 metres in north easterly direction.
- iii the south side from a point 398 metres east of its junction with the A618 Pleasley Road, for a distance of 180 metres in north easterly, then south easterly direction
