Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Rotherham Road Maltby

- i) The north side from a point 45 metres south east of its junction with the eastern kerb line of Addison road to a point 48 metres north west of its junction with the western kerb line of Addison Road.

#### Bawtry Road Hellaby and Rotherham Road Maltby

- i) North side from a point 160 metres West of the western kerb line of Old Hellaby Lane in an easterly direction to a point 45 metres south east of its junction with the eastern kerb line of Addison road.
- ii) South side from a point 171 metres West of the western kerb line of Hellaby Hall Road in an easterly direction to a point 35 metres east of its junction with the eastern kerb line of Harvest Close.

#### Hellaby Hall Road Hellaby

- i) West side from its junction with the southern kerb line of Bawtry Road to a point 10 metres in a southerly direction.
- ii) East side from its junction with the southern kerb line of Bawtry Road to a point 10 metres in a southerly direction.

#### Greenhill Avenue Hellaby

- i) West side from its junction with the southern kerb line of Bawtry Road to a point 10 metres in a southerly direction
- ii) East side from its junction with the southern kerb line of Bawtry Road to a point 10 metres in a southerly direction.

#### Harvest Close Maltby

- i) West side from its junction with the southern kerb line of Bawtry Road to a point 10 metres in a southerly direction
- ii) East side from its junction with the southern kerb line of Bawtry Road to a point 10 metres in a southerly direction.

This Order is made on the 31<sup>st</sup>. January 2024 and shall come into force on the 5<sup>th</sup>. February 2024 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.223) Order 2024.
