No Waiting At Any Time  
Sheffield Road Westgate and Foundary Place Rotherham Town Centre

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1

Schedule 1 No Waiting At Any Time

Sheffield Road Rotherham Town Centre

- i) the northwest side from a point 63 metres north east of the eastern kerb line of Centenary Way to a point 141 metres north east of the northern kerb line of Marsh street;
- ii) the north west side from a point 16 metres north east of the projected north eastern kerb line of Wheathill Street for a distance of 21 metres in a south westerly direction;
- iii) the north west side from a point 30 metres south west of the western kerb line of Westgate for a distance of 20 metres in south westerly direction;

- iv) the north west side from a point of 50 metres south west of the western kerb line of Westgate for a distance of 54 metres in south westerly direction.
- v) the south east side from a point 63 metres north east of the eastern kerb line of Centenary Way to a point 68 metres north east of the north eastern kerb line of old Sheffield road;
- vi) the south east side from its junction with the western kerb line of Westgate for a distance of 35 metres in a south westerly direction;
- vii) the south east side from a point 72 metres south west of the western kerb line of Westgate for a distance of 20 metres in a south westerly direction.
- viii) the south east side from a point 64 metres north east of the north eastern kern line of Wheathill street for a distance of 9 metres in a north easterly direction.
- ix) the south east side from a point 4 metres north east of the north eastern kern line of Wheathill street for a distance of 14 metres in a south westerly direction.
- x) the south east side from a point 14 metres north east of the north eastern kern line of Wheathill street for a distance of 14 metres in a north easterly direction

#### Westgate Rotherham Town Centre

- i) the east side from its junction with the northern kerb line of Wilfred Street to the southwestern kerb line of High Street.
- ii) the east side from a point 65metres in a south westerly direction from the southern kerb line of Oil Mill Fold for a distance of 60 metres in a south westerly direction.
- iii) the east side from its junction with the southern kerb line of Wilfred Street to appoint 9 metres south of its southern kerb line of Oil Mill Fold.
- iv) the east side from its junction with the southern kerb line of Ship Hill to a point opposite junction with the northern kerb line of Main Street.
- v) the west side from its junction with the southern kerb line of Main Street for a distance of 31 metres in a southerly direction.
- vi) the west side from a point 8 metres north of the northern kerb line of Burrell Street for a distance of 19 metres in a southerly direction.

- vii) the west side from a point of 10 metres south of the southern kerb line of Burrell Street for a distance of 34 metres in a south westerly direction.
- viii) the west side of a point 94 metres south of the southern kerb line of Burrell Street for a distance of 13 metres in a south westerly direction.
- ix) the west side of a point 15 metres north of the northern kerb line of Water Lane Street for a distance of 34 metres in a south westerly direction.
- x) the west side from its junction with the northern kerb line of Main Street for a distance of 55 metres in a northerly direction.
- xi) the west side from a point 54 metres south of the southern kerb line of Main Street for a distance of 46 metres in a southerly direction.

## Schedule 2

Schedule No 1

No Waiting At Any Time

Foundary Place Rotherham Town Centre

Both sides from its junction with Westgate to the end of the cul de sac – The Whole

Sheffield Road Rotherham Town Centre

- i) the northwest side from a point 56 metres northeast of the eastern kerb line of Ickles Roundabout for a distance of 136 metres in a north easterly direction.
- ii) the northwest side from a point 120 metres from northern kerb line of Marsh Street for a distance of 16 metres in a north easterly direction.
- iii) the northwest side from a point 155 metres from the northern kerb line of Marsh Street for a distance of 15 metres in a north easterly direction.
- iv) The northwest side from a point 21 metres from the north western kerb line of Westgate to a distance of 98 metres in south westerly direction



- v) the southeast side from a point 56 metres northeast of the eastern kerb line of Ickles Roundabout to a point 77 metres northeast of the eastern kerb line of Old Sheffield Road.
- vi) the southeast side from a point 80 metres from the eastern kerb line of the Old Sheffield Road for a distance of 10 metres in a north easterly direction.
- vii) the southeast side from a point 96 metres from the eastern kerb line of the Old Sheffield Road for a distance of 12 metres in a north easterly direction.
- viii) the southeast side from a point 167 metres from the eastern kerb line of the Old Sheffield Road for a distance of 12 metres in a north easterly direction.
- ix) the southeast side from the south western kerb line of Westgate for a distance of 67 metres in south westerly direction.
- x) the southeast side from a point 74 metres from the south western kerb line of Westgate for a distance of 13 metres in south westerly direction

#### Westgate Rotherham Town Centre

- i) the west side from a point 15 metres from the southern kerb line of Water Lane for a distance of 34 metres in a northerly direction.
- ii) the west side from a point 26 metres from the northern kerb line of Water Lane for a distance of 8 metres in a northerly direction.
- iii) the west side from a point 48 metres from the northern kerb line of Water Lane for a distance of 204 metres in a northerly direction.
- iv) the west side from its junction with Main Street for a distance of 44 metres in a northerly direction to its junction with Market Place.
- v) the east side from its junction with Sheffield Road for a distance of 74 metres in a northerly direction.
- vi) the east side from a point 2 metres from the southern kerb line of Oil Mill Fold for a distance of 6 metres in a northerly direction
- vii) the east side from a point 10 metres from the southern kerb line of Wilfred Street for a distance of 20 metres in a northerly direction.
- viii) the east side from a point 1 metres from the southern kerb line of Unity Place for a distance of 8 metres in a northerly direction.

ix) the east side from a point 28 metres from the northern kerb line of Unity Place for a distance of 84 metres in a northerly direction to its junction with Ship Hill Road.

This Order is made on the 31<sup>st</sup>. January 2024 and shall come into force on the 5<sup>th</sup>. February 2024 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.222) Order 2024
