Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting at Any Time

New Orchard Lane, Thurcroft.

- i Eastern kerbline from the extended Southern kerbline of Sycamore Drive for a distance of 17.00m in a Southerly direction.
- ii Western kerbline from the extended Southern kerbline of unnamed road for a distance of 17.00m in a South-westerly direction.
- iii Western kerbline from the extended Northern kerbline of New Orchard Road for a distance of 10.00m in a Northerly direction.
- iv Western kerbline from the extended Southern kerbline of New Orchard Road for a distance of 10.00m in a Southerly direction.

- v Western kerbline from the extended Northern kerbline of Osbert Drive for a distance of 10.00m in a Northerly direction.
- vi Western kerbline from the extended Southern kerbline of Osbert Drive for a distance of 10.00m in a Southerly direction.
- vii North-westerly kerbline from the extended Northern kerbline of unnamed road for a distance of 42.00m in a North-easterly direction.
- viii South-eastern kerbline from the extended North-eastern kerbline of New Orchard Lane (unadopted) for a distance of 13.00m in a North-easterly direction.
- ix North-eastern kerbline from the extended South-eastern kerbline of New Orchard Lane for a distance of 7.00m in an Easterly direction.
- xi South-eastern kerbline from the extended North-eastern kerbline of Sycamore Drive for a distance of 32.00m in a North-easterly direction.
- xii Eastern kerbline from a point 159.00m from the extended Southern kerbline of Sycamore Drive for a distance of 27.00m in a Southerly direction.

Sycamore Drive, Thurcroft.

- i North-eastern kerbline from the extended South-eastern kerbline of New Orchard Lane for a distance of 11.00m in an Easterly direction.

- ii Southern kerbline from the extended Eastern kerbline of New Orchard Lane for a distance of 17.00m in an Easterly direction.

New Orchard Road, Thurcroft.

- i North-western kerbline from the extended Western kerbline of New Orchard Lane for a distance of 10.00m in a South-westerly direction.

- ii South-eastern kerbline from the extended Western kerbline of New Orchard Lane for a distance of 10.00m in a South-westerly direction.

Osbert Drive, Thurcroft.

- i Northern kerbline from the extended Western kerbline of New Orchard Lane for a distance of 10.00m in a Westerly direction.

- ii Southern kerbline from the extended Western kerbline of New Orchard Lane for a distance of 10.00m in a Westerly direction.
