No Waiting At Any Time
Brecks Crescent, Beech Avenue and Bawtry Road service road, Brecks,
Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1

To be revoked

Schedule 1 No Waiting At Any Time

Brecks Crescent, Brecks

- i) west side from its junction with Bawtry Road (service road) for a distance of 60 metres in a northerly direction.
- ii) east side from its junction with Bawtry Road (service road) for a distance of 10 metres in a northerly direction.
- iii) east side from a point 34 metres north of its junction with Bawtry Road (Service Road) for a distance of 26 metres in a northerly direction.

Bawtry Road (service road), Brecks

- i) Both sides- the whole.

Schedule 2

To be introduced

Schedule No 1

No Waiting At Any Time

Brecks Crescent, Brecks

- i) west side from its junction with the northern kerb line of Bawtry Road for a distance of 62 metres in a northerly direction.
- ii) east side from its junction with the northern kerb line of Bawtry Road for a distance of 37 metres in a northerly direction.
- iii) east side from a point 42 metres north of its junction with the northern kerb line of Bawtry Road for a distance of 21 metres in a northerly direction

Beech Avenue, Brecks

- i) west side from its junction with the northern kerb line of Bawtry Road for a distance of 25 metres in a northerly direction.
- ii) east side from a point 21 metres north of its junction with the northern kerb line of Bawtry Road around the radius to a point where it meets the entrance to the adjacent service centre in a southerly then easterly direction.

This Order is made on the 31st. January 2024 and shall come into force on the 5th. February 2024 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.221) Order 2024.
