High Street Rotherham Town Centre

1. Rotherham Borough Council in exercise of its powers under Section 1(1), 2(1) and (2) and 4(2) of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order, the sole effect of which is to reproduce and continue in force the provisions of the Experimental Traffic Regulation Order to amend The Rotherham Borough Council (Various Roads, Rotherham) (Town Centre Movement Restrictions, Consolidation Order 2014) Order 2015:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Town Centre Movement Restrictions) Consolidation Order 2014 ("the Order") shall have effect as though:-

- (i) the words specified in Schedule 1 hereto were deleted from the Schedule 9 of the Order affecting High Street Rotherham Town Centre "One way street"
- (ii) the words specified in Schedule 2 hereto were included in Schedule 9 of the Order affecting High Street Rotherham Town Centre "One way street".
- (iii) the words specified in Schedule 3 hereto were deleted from the Schedule 12 of the Order affecting Wellgate Rotherham Town Centre "Prohibited Turn"
- (iv) the words specified in Schedule 4 hereto were included in Schedule 13 of the Order affecting Wellgate Rotherham Town Centre "Prohibited turn except cycles".
- (v) the words specified in Schedule 5 hereto were deleted from the Schedule 7 of the Order affecting High Street Rotherham Town

Centre "Prohibition of Vehicles except for loading between 4pm and 10am and Permit Holders"

- (vi) the words specified in Schedule 6 hereto were included in Schedule 7 of the Order affecting High Street Rotherham Town Centre "Prohibition of Vehicles except for loading between 4pm and 10am and Permit Holders"
