Broad Street, Beale Way Midland Street and Rail Mill Way Parkgate  
Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 10 of the 2011 Order "No Waiting Mon-Sat 8am-6pm" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1

**Schedule No 10**  
**No waiting Mon-Sat 8am-6pm**

Broad Street, Parkgate

- (i) the east side from its junction with the north eastern kerbline of Great Eastern Way to a point 46 metres north of the northern kerbline of Lloyd Street.
- (ii) the west side from its junction with the northern kerbline of Taylors Lane to its junction with the southern kerbline of Wannop Street

## Schedule 2

To be introduced

### **Schedule No 1** **No waiting At Any Time**

Beale Way, Parkgate

- (i) the north side from its junction with Great Eastern Way to its junction with the eastern kerbline of Rail Mill Way.
- (ii) the south side from its junction with Rotherham Road to its junction with the eastern kerbline of Rail Mill Way.

Broad Street, Parkgate

- (i) the east side from its junction with Great Eastern Way to a point 46 metres north of the northern kerbline of Lloyd Street.
- (iii) the west side from its junction with Taylors Lane to its junction with the southern kerbline of Wannop Street.

Midland Street, Parkgate

- (i) the north side from its junction with Rotherham Road for a distance of 10 metres in an easterly direction.
- (ii) the north side from a point 22 metres east of its junction with the eastern kerbline of Rotherham Road to its termination.
- (iii) the south side the whole

Rail Mill Way

- (i) Both sides the whole

Rotherham Road Parkgate

- (i) the west side from its junction with the northern kerbline of The Gateway to its junction with the southern kerbline of Taylors Lane.
- (ii) the east side from its junction with the northern kerbline of Midland Street to its junction with the southern kerbline of Beale Way.

This Order is made on the 17<sup>th</sup>. October 2019 and shall come into force on the 21<sup>st</sup>. October 2019 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.181) Order 2019.
