Southeast Kerbline from the extended South Western Kerbline of Charnwood Street for a distance of 5.00m in a South Westerly direction

**Charnwood Street, Swinton** 

Southern Western Kerbline from the extended South Eastern Kerbline of Queen Street for a distance of 10.00m in a South easterly direction.

## **Charles Street, Swinton**

- Southern Kerbline from a point 5.00m from the extended Western Kerbline of Lime grove for a distance of 24.00m in an Westerly direction.
- Northern Kerbline from a point 5.00m from the extended Western Kerbline of Lime Grove for a distance of 29.00m in a Westerly direction

# Rowms Lane, Swinton

- North Western kerbline from the extended Southern Western kerbline of Marriott Road for a distance of 100.00m in a South Westerly direction.
- North Western kerbline from the extended North Eastern kerbline of Marriott Road for a distance of 17.00m in a North Easterly direction.
- South Eastern kerbline from the extended North Eastern kerbline of Don Pottery Yard for a distance of 5.00m in a North Easterly direction.
- South Eastern kerbline from the extended South Eastern kerbline of Don Pottery Yard for a distance of 37.00m in a South Westerly direction.

#### **Market Street, Swinton**

Southern kerbline from the extended North Western kerbline of Rowms Lane for a distance of 10.00m in a Westerly direction.

Northern kerbline from the extended North Western kerbline of Rowms Lane for a distance of 24.00m in a Westerly direction.

## Marriott Road, Swinton

Both sides from the extended North Western kerbline of Rowms Lane for a distance of 10.00m in a North Westerly direction.

#### **Talbot Road, Swinton**

Both sides from the extended South Eastern kerbline of Rowms Lane for a distance of 15.00m in a South Easterly direction.
