Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Sough Hall Avenue, Thorpe Hesley

- i Both Sides for a distance of 22.00m from the extended South Eastern kerbline of Thorpe Street in a South easterly direction.

Thorpe Street, Thorpe Hesley

- i South Eastern kerbline for a distance of 25.00m from the extended North Eastern kerbline of Sough Hall Avenue in a North Easterly direction.

New Street, Thorpe Hesley

- i Southern kerbline for a distance of 10.00m in an Easterly direction from the extended Eastern kerbline of Brook Hill.

Church Street, Kimberworth

- i Northern Eastern Kerbline for a distance of 10.00m from the extended South Eastern Kerbline of South Street in a South Easterly direction.

Kimberworth Road, Kimberworth.

- i Northern kerbline for a distance of 4.00m in a Westerly direction from the extended Western kerbline of Bradgate Lane.
- ii Northern kerbline for a distance of 20.00m in an Easterly from the extended Eastern Kerbline of Bradgate Lane

Nursery Road, North Anston

- i South Eastern Kerbline for a distance of 15.00m in a North easterly direction form the extended North Eastern kerbline of Norfolk Drive.

Mortains, Todwick

- i Both Sides for a distance of 20.00m from the extended Eastern kerbline of Kiveton Lane.

Kiveton Lane, Todwick

- i Eastern kerbline for a distance of 15.00m in a Northerly direction from the extended Northern kerbline of Mortains.
- ii Eastern kerbline for a distance of 15.00m in a Southerly direction from the extended Southern kerbline of Mortains.

Alpina Way, Swallownest.

- i Both Sides for a distance of 20.00m in a North Easterly direction from the extended North Eastern kerbline of Mansfield Road.

Worksop Road, Swallownest.

- ii Northern Kerbline for a distance of 80.00m in an Easterly direction from the extended Eastern Kerbline of Eden Grove.
- v Northern kerbline for a distance of 13.00m in a Westerly direction from the extended Westerly kerbline of Eden Grove.

Sheep Cote Road, Brecks.

i

Both sides for a distance of 50.00m in Southerly direction from the extended Southern kerbline of East Bawtry Road.

Northern Kerbline from a point 16.00m from the extended Eastern kerbline of Eden Grove for distance of 65.00m in an Easterly direction
