Barrowfield Lane, Barrow Hill, Main Street, Cortworth Lane and Clayfield Lane  
Wentworth Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

**Main Street, Wentworth**

- ii the south west side from a point 15 metres west of its junction the projected western kerbline of Barrowfield Lane for a distance of 255 metres.

**Barrowfield Lane, Wentworth**

- i Western kerbline from the extended northern kerbline of Barrow Hill for a distance of 15.00m in a Northerly direction.

- ii Eastern kerbline from the extended northern kerbline of Main Street for a distance of 8.00m in a Northerly direction.

#### **Barrow Hill, Wentworth**

- i Northern kerbline from the extended Western kerbline of Barrowfield Lane for a distance of 20.00m in a Westerly direction.

#### **Main Street, Wentworth**

- i North Eastern kerbline from the extended Eastern kerbline of Barrowfield Lane for a distance of 10.00m in a South Easterly direction.
- ii North Eastern kerbline from a point 33.00m from the extended Eastern kerbline of Barrowfield Lane for a distance of 48.00m in a South Easterly direction.
- iii The South western kerbline from the extended Eastern kerbline of Churchfield Lane for a distance of 356.00m in a South Easterly direction.
- iv South Western kerbline from the extended North Western kerbline of Friars Croft for a distance of 31.00m in a North Westerly direction.
- v South Western kerbline from the extended North Western kerbline of unspecified entrance for a distance of 55.00m in a North Westerly direction.
- vi South Western kerbline from the extended South Eastern kerbline of Friars Croft for a distance of 15.00m in a South Easterly direction.

#### **Cortworth Lane, Wentworth**

- i North Western kerbline from the extended Western kerbline of Clayfield Lane for a distance of 10.00m in a South Westerly direction.
- ii North Western kerbline from the extended Eastern kerbline of Clayfield Lane for a distance of 10.00m in a North Easterly direction.



**Clayfield Lane, Wentworth**

- i Both sides from the extended North Western kerbline of Cortworth Lane for a distance of 15.00m in a North Westerly direction.

This Order is made on the 1<sup>st</sup>. September 2016 and shall come into force on the 5<sup>th</sup>. September 2016 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.122) Order 2016.
