The Council of the Borough of Runnymede ("the Council") in exercise of its powers under Sections 32 and 35 (1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers with the consent of the County Council of Surrey given under Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

The Borough of Runnymede (Off Street Parking Places) Order 2008 (hereinafter referred to as "the Principal Order") shall have effect as if :-

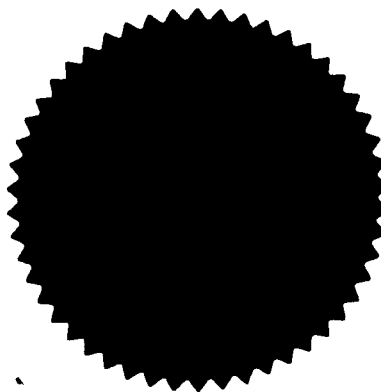
1. Schedule 19 in Schedule 1 to this Order was inserted after Schedule 18 of the Principal Order.
