THE RUSHMOOR BOROUGH COUNCIL (ONE-WAY STREETS AND OTHER PRESCRIBED DIRECTIONS, ALDERSHOT) (CONSOLIDATION) ORDER,2015

The Rushmoor Borough Council ("the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1(1), 2(1) to (3), 4 and 124 of the Road Traffic Regulation Act, 1984 ("The 1984 Act"), Part IV of Schedule 9 to the 1984 Act, the Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hampshire) (Borough of Rushmoor) Order, 2002 ("the Order")the Traffic Management Act 2004 ("the 2004 Act"), and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

- 1. This Order may be cited as the Borough of Rushmoor (One-Way Streets and Other Prescribed Directions, Aldershot) (Consolidation) Order, 2015 and shall come into operation on the /////
- 2. No person shall cause or permit any motor vehicle to proceed in the lengths of road specified in Schedule 1 to this Order other than in the direction specified in that Schedule.
- 3. No person shall cause or permit any motor vehicle or pedal cycle to proceed in the lengths of road specified in Schedule 2 to this Order.
- 4. No person shall cause or permit any motor vehicle except Buses, Hackney Carriages, and Goods Vehicles performing loading/unloading to proceed in the lengths of road specified in Schedule 3 to this Order.
- 5. No person shall cause or permit any motor vehicle except Hackney Carriages to proceed in the lengths of road specified in Schedule 4 to this Order.
- 6. No person shall cause any motor vehicle proceeding along the roads specified in Column (1) of Schedule 5 to the Order to make a right hand turn into the roads specified in Column (2) of the said Schedule.
- 7. All vehicles proceeding in the lengths of road specified in Column (1) of Schedule 6 to this Order shall be required to turn left only as specified in Column (2) of the said Schedule.
- 8. No person shall cause or permit any vehicle with a width exceeding 6'6" or 2 metres to proceed along the lengths of road as specified in Schedule 7 to this Order.
- 9. No person shall cause or permit any vehicle whose length exceeds nine metres to proceed in the length road, as specified in Schedule 8, except for the purpose of loading or unloading at premises in that section of road.

- 10. No person shall cause or permit any vehicle exceeding the maximum gross weight of 7.5T to proceed along the lengths of road as specified in Schedule 9 to this Order except for access to premises or land adjacent to the roads specified in Schedule 9.
- 11. Nothing in Articles 2 to 9 of this Order shall apply to:
 - i. Motor vehicles being used for fire, police or ambulance purposes specifically engaged in operational work and, in particular, BMA badge holders.
 - ii. Any motor vehicle under direction or with the permission of a Police Constable in uniform.
 - iii. Any motor vehicle being used in the service of the Local Authority or Water Authority in pursuance of statutory powers or duties.
- 12. The Orders specified in Schedule 10 to this Order are hereby revoked
- 13. The Council in exercise of its powers under the Local Authorities (Transport Charges) Regulations 1998 (SI 1998 No. 948) and the Order may make a reasonable charge for any dispensation issued in contravention of any traffic regulation order contained in this Order to cover the cost of administration.

From Victoria Road southwards to Birchett Road.

Lower Newport Road

From North Lane westwards and then southwards to Ash Road

Perowne Street

From Alexandra Road southwards to Queens Road.

Pickford Street

From High Street southwards to Sebastopol Road.

Queens Road

From Barrack Road westwards to Lime Street.

Sebastopol Road

From Pickford Street eastwards and then southwards to Crimea Road.

St. Michael's Road

From a point 5 metres south west of its junction with High Street in a north easterly direction to High Street.

Station Road

From The Grove northwards to Victoria Road.

Victoria Road

From Grosvenor Road eastwards to Windsor Way.

From a point 25 metres east of its junction with Albert Road eastwards to High Street.

Windmill Road

From the north east boundary of No. 31 Windmill Road in a south westerly direction to a point 74 metres east of its junction with High Street.

Windsor Way

From Victoria Road south westwards to Arthur Street.

From its junction with Manor Road in a northerly direction for a distance of 3 metres.
