SALFORD CITY COUNCIL (HOPE HOSPITAL AREA, PHASE 2) (RESIDENTS' PARKING SCHEME AND PROHIBITION OF WAITING) ORDER 2004

The Council of the City of Salford (hereinafter referred to as "the Council") under Sections 1, 2, 3, 4, 9, 32, 35, 45, 47, 49 and 53 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (City of Salford) Order 2001 (Statutory Instrument 2001 No. 894) made by the Secretary of State for Environment, Transport and the Regions pursuant to Schedule 3 of the Road Traffic Act 1991 and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with part III of Schedule 9 of the said Act 1984, hereby made the following Order:-

PART 1

Definitions

- 1 In this Order the following definitions have the meanings hereby assigned to them, that is to say:-

"disabled person's badge" has the same meaning as in the 2000 Regulations and the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

"disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge and which immediately before or after any period of waiting allowed by virtue of this Order has been or is to be driven by a disabled person or has been or is to be used for carrying disabled persons as passengers.

"driver" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place.

"goods" has the same meaning as in the Road Traffic Act 1988.

"household" means the postal address of which is any of

"owner" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place.

"parking place" means the part of the road authorised by this Order to be used as a parking place.

"parking space" means a space in the parking place which is provided for the leaving of a vehicle.

"a person duly authorised by the Council" means an Officer of the Council authorised for the purpose of this Order by Director of Development Services or other Officer of the Council.

"permit" means a permit issued under the provisions of Article 19 of this Order.

"permit holder" means a person to whom a permit has been issued under the provisions of Article 19 of this Order.

"postal packets" means the same as in the Post Office Act 1953.

"relevant position" means:-

- (i) the badge and/or disc are exhibited on the dashboard or fascia of the vehicle; or
- (ii) where the vehicle is not fitted with a dashboard or fascia the badge and/or disc are exhibited in a conspicuous position on the vehicle so that the badge and/or disc are clearly legible from the outside of the vehicle.

"resident" means a person whose usual residence is at any of the households to which this Order relates.

"telecommunications apparatus" means the same as in the Telecommunications Act 1984.

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the Act.

"universal service provider" has the same meaning as in the Postal Services Act 2000.

"the 1994 Regulations" means the Traffic Signs Regulations and General Directions 1994.

"the 2000 Regulations" means the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

"Parking Attendant" means a person authorised by or on behalf of the City of Salford under Section 63A of the Road Traffic Regulation Act 1984 to supervise and enforce the restrictions imposed by this Order

"Penalty Charge" and "Reduced Penalty Charge" means a charge set by the City of Salford under the provisions of Section 74 of the Road Traffic Act 1991 in accordance with guidance given by the Secretary of State for Environment, Transport and the Regions which is to be paid in the manner described in the penalty charge notice within 28 days of the date of the notice or in the case of a reduced penalty charge, within 14 days of the date of the notice

"Penalty Charge Notice" means a notice issued by a parking attendant pursuant to the provisions of Section 66 of the Road Traffic Act 1991

PART II

Prohibition of Waiting Limited Waiting and No Stopping

- 2(a) Save as provided in Article 3 and 5 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or a parking attendant cause or permit any vehicle to wait at any time on the lengths of road in Schedule 1 below.
- (b) Save as provided in Article 3 and 5 of this Order, no person shall, except upon the direction of a Police Constable in uniform or a parking attendant cause or permit any vehicle to wait between the hours of 9.00 a.m. to 5.00 p.m. Monday to Friday on the lengths of road specified in Schedule 2 below.
- (c) Save as provided in Articles 3, 4 and 5 of this Order, no person shall, except upon the direction of a Police Constable in uniform or a parking attendant cause or permit any vehicle except a vehicle displaying a valid residents' parking permit to wait at any time on the lengths of road specified in Schedule 3 below.
- (d) Save as provided in Articles 3, 4 and 5 of this Order, no person shall, except upon the direction of a Police Constable in uniform or a parking attendant cause or permit any vehicle except a vehicle displaying a valid residents' parking permit to wait between the times of 9.00 a.m. to 5.00 p.m. Monday to Friday on the lengths of road specified in Schedule 4 below.
- (e) Save as provided in Article 6 of this Order, no person shall, except upon the direction of a Police Constable in uniform or a parking attendant cause or permit any vehicle except a bus, to stop at any time on the lengths of road specified in Schedule 5 below.
- (f) Save as provided in Article 3 and 5 of this Order, no person shall, except upon the direction of a Police Constable in uniform or a parking attendant cause or permit any vehicle except a vehicle displaying a valid residents' parking permit to wait at any time on the lengths of road specified in Schedule 6 below.
- (g) If a vehicle is left at any time in contravention of the provisions of this Order a penalty charge will be payable.

- (h) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by Section 66 of the Road Traffic Act 1991 may then be issued by a parking attendant in accordance with the requirements of Section 66 of that Act.
3. Nothing in Article 2 of this Order shall prohibit any person from causing or permitting any vehicle to wait in the lengths of road specified in schedule 1 to this Order for so long as may be necessary:
- a) to enable a person to board or alight from the vehicle;
 - b) to enable the vehicle, if it cannot be conveniently used for such purpose in any other road, to be used in connection with any wedding or funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so specified or the laying, erection, alteration or repair in or near the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus;
 - c) to enable the vehicle, if it is in the service of the Royal Mail or other universal service provider to be used for the purpose of delivering or collecting postal packets;
 - d) to enable the vehicle to be used in the length of road so specified for Police, ambulance, fire brigade, local authority or water authority purposes when used in pursuance of statutory powers or duties;
 - e) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond the control of the driver, or to such waiting as is necessary to prevent an accident;
 - f) for the purposes of loading or unloading the vehicle whilst it is in actual use in connection with the removal or delivery of furniture to or from any premises fronting, adjoining or abutting the said lengths of road provided that notice is given twenty four hours in advance to the Council and its consent obtained.
4. Nothing in Article 2(c) and Article 2(d) of this Order shall prohibit any vehicle to wait on the lengths of road specified in Schedule 3 and Schedule 4 for a period not exceeding 30 minutes (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road or part of road on the same day).
5. Nothing in Article 2(a), 2(b) 2(c), 2(d) and 2(f) shall prohibit a disabled person's vehicle which displays in the relevant position a blue disabled person's badge or an orange disabled person's badge with a parking disc (on which the driver or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the lengths of road referred to in those Articles for a period not exceeding 3 hours, not being separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road or part of road on the same day.

6. Nothing in Article 2(e) of this Order shall prohibit any person to cause or permit a vehicle to stop on the lengths of road specified in Schedule 5.
- a) if a vehicle is being used for the removal of any obstruction to traffic; or
 - b) if the vehicle is being used in the service of the Council or with the permission of the Chief Constable in exercise of statutory powers or duties and whilst being so used in such service it is necessary for the vehicle to wait in that prohibitive area; or
 - c) in any case where the person in control of the vehicle is required by law to stop or is obliged to do so in order to avoid an accident, or is prevented from proceedings by circumstances outside his control; or
 - d) if the vehicle is being used for police, fire brigade or ambulance purposes.

PART III

Parking Place for Vehicles Authorisation of Use of Parking Places

7. Each of the lengths of road specified in Schedule 3, 4 and 6 of this Order are authorised as a parking place for residents who hold and display a valid residents' parking permit.
8. Save as provided in Articles 13 and 14 of this Order the driver of a vehicle which does not display a valid resident's parking permit shall not use any of the parking places listed in Schedule 6 unless authorised to do so by a Police Constable in uniform or a parking attendant.
9. The driver of a vehicle using any of the parking places specified in Schedules 3, 4 and 6 shall not use the parking places so as unreasonably to prevent access to premises adjoining the road, or the use of the road by other persons, or so as to be a nuisance and provided always that a Police Constable in uniform or a parking attendant, may at any time require the driver of the vehicle to move it if it is reasonably necessary for the purpose of preventing obstruction or in the case of an emergency move or cause to be moved to any place he thinks fit, any vehicle left in a parking place. Anyone, who is the subject of a complaint may have their permit revoked.
10. The driver of a vehicle using the parking place shall stop the engine as soon as the vehicle is in a position in the parking place, and shall not start the engine except when about the change the position of the vehicle in, or to depart from, the parking place.
11. No person shall use a vehicle whilst it is in the parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skills or services or any other person's skill or services.
- 12.(a) Any person duly authorised by the Council may suspend the use of the parking place or any part thereof whenever he considers such suspension reasonable necessary:-

- (i) for the purpose of facilitating the movement of traffic or promoting its safety;
- (ii) for the convenience of the occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from an office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (iii) for the convenience of the occupiers of premises adjacent to the parking place at times of wedding or funerals or on other special occasions.
- (iv) for the purpose of any building operation, demolition or excavation adjacent to the parking place or the maintenance or reconstruction of the parking place or the laying, erection, alteration or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus;

and he has made an Order and/or given notice as required in the appropriate legislation.

- (b) Any person authorised by the Council suspending the use of the parking place or any part thereof in accordance with the provisions of Paragraph (a) of this Article shall thereupon place or cause to be placed in or adjacent to that parking place or part thereof the use of which is suspended a traffic sign or notice indicating that waiting by vehicles is prohibited.
 - (c) Save as provided in Articles 13 and 14 of this Order no person shall cause or permit any vehicle to be left in the parking place or part thereof, as the case may be, during such period as there is in or adjacent to that parking place or part thereof a traffic sign or notice placed in pursuance of paragraph (b) of this Article.
13. Nothing in Articles 7, 8 and 12(c) of this order shall prohibit any person from causing or permitting any vehicle to wait in the parking place so long as it may be necessary:-
- (a) to enable a person to board or alight from the vehicle;
 - (b) to enable the vehicle, if it cannot be conveniently used for such purpose in any other road, to be used in connection with any wedding or funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so specified or the laying, erection, alteration or repair in or near the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus;
 - (c) to enable the vehicle, if it is in the service of the Royal Mail or other universal service provider to be used for the purpose of delivering or collecting postal packets;
 - (d) to enable the vehicle to be used for police, ambulance, fire brigade, local authority or water authority purposes when used in pursuance of statutory powers or duties;

- (e) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond the control of the driver, or to prevent an accident.
 - (f) To deliver to or collect from or load or unload goods at any premises fronting onto the parking place provided that no vehicle so engaged shall wait for longer than 30 minutes outside the same premises without the permission of a Police Constable in uniform or a parking attendant.
 - (g) To enable the vehicle to be used in conjunction with the removal of furniture from an office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository.
14. Nothing in Articles 7, 8 and 12(c) of this Order shall apply if the vehicle is being used by a legally qualified general medical practitioner, district nurse, midwife or similar people when visiting a patient so long as the vehicle concerned is clearly marked Doctor, Midwife etc., and the visit is expected to be less than 15 minutes' duration.
 15. When a vehicle is left in the parking place in contravention of any of the provisions contained in Article 8 of this Order a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be removed from the parking place.
 16. Any person removing a vehicle or altering its position by virtue of Article 15 of this Order, may do so by towing or driving the vehicle or in such other manner as he may think necessary to enable him to remove it or alter its position as the case may be.
 17. When a person duly authorised by the Council removes or makes arrangements for the removal of a vehicle from the parking place by virtue of Article 15 of this Order, he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle and its contents.
 18. Nothing in Article 8 of this order shall render it unlawful to cause or permit any vehicle to wait in the parking places listing in Schedules 3, 4 and 6 of this Order if the vehicle is a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc issued by an local authority in accordance with the 2000 Regulations, or a badge having effect under those Regulations as if it were a disabled person's badge.

Application for and issue of Permits

- 19.(a) Each household will be issued with 4 parking permits for use by the residents and bona fide visitors to their premises. Upon receipt of the said permits, the resident shall acknowledge receipt of the same by signing and returning the duplicate of the letter accompanying the permits.
- (b) The Council may at their discretion issue a permit with or without charge to any person who in the opinion of the Council requires to park in any parking place specified.
- (c) The issue of a permit under the foregoing provisions of this Article shall not be construed as if any parking space in the parking place was reserved solely for the use of a permit holder.
- (d) The permits will remain the property of the City of Salford.

Surrender, Withdrawal and Validity of Permits

- 20(a) A permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any of the events set out in paragraph (c) of this Article.
- (b) (i) The Council may, by notice in writing served on the permit holder by sending the same by postal service to the permit holder at the address shown by that person on the application for the permit or at any address believed to be that person's place of abode, withdraw a permit entirely at its own discretion and the permit holder shall surrender the permit to the Council within 48 hours of the receipt of the aforementioned notice.
- (ii) A permit shall cease to be valid on the occurrence of any one of the events set out in paragraph (c) of this Article.
- (c) The events referred to in the foregoing provisions of this Article are:-
- (i) All members of the household cease to be resident at the relevant address;
- (ii) the withdrawal of such permit by the Council under the provisions of Paragraph (b) of this Article;
- (d) Any person misusing the permits by giving/selling them to unauthorised persons will have their permits revoked.

Application for and issue of Duplicate Permits

- 21(a) If a permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise the permit holder shall surrender it to the Council and the Council, upon receipt of the permit, shall issue a duplicate permit so marked.
- (b) if a permit is lost or destroyed, the permit holder may apply to the Council for the

issue to him of a duplicate permit and the Council, upon being satisfied as to such loss or destruction shall issue a duplicate permit so marked and upon such issue the permit which it duplicates shall become invalid.

- (c) The Council reserves the right to charge for the issue of duplicate permits.

Form of Permit

22. A permit shall be in writing and shall bear the words "Parking Permit" and shall include the following particulars:-
- (a) The title of this Order i.e. "Salford City Council (Hope Hospital Area, Phase 2) (Residents' Parking Scheme and Prohibition of Waiting) Order 2004".
 - (b) The Permit number.
 - (c) The period during which the permit shall remain valid.

Display of Permits

23. At all times during which a vehicle is left in a parking place there shall be displayed on the front or near side of the vehicle a valid parking permit.

Restriction on the Removal of Permits

24. When a permit has been displayed on a vehicle in accordance with the provisions of Article 20 of this Order, no person not being the driver of the vehicle shall remove the permit from the vehicle unless authorised to do so by the driver of the vehicle.

PART V

General

25. The Council reserves the right to introduce charges for the issue of permits and duplicate permits.
26. This order shall come into Operation on the 23rd day of January 2004 and may be cited as Salford City Council (Hope Hospital Area, Phase 2) (Residents' Parking Scheme and Prohibition of Waiting) Order 2004.

Wilton Road, west side, from a point 40 metres north of the northern kerbline of Eccles Old Road in a northerly direction for a distance of 26 metres.

Wilton Road, west side, from a point 17 metres south of the southern kerbline of Vauban Drive in a northerly direction to a point 10 metres north of the northern kerbline

Wilton Road, west side, from a point 10 metres south of the southern kerbline of Acacia Drive in a northerly direction to a point 25 metres north of the northern kerbline of Acacia Drive.

Wilton Road, west side, from a point 10 metres south of the southern kerbline of Hawthorn Drive in a northerly direction to a point 10 metres north of the northern kerbline of Hawthorn Drive.

Wilton Road, east side, from a point 40 metres north of the northern kerbline of Eccles Old Road in a northerly direction for a distance of 30 metres.

Wilton Road, east side, from a point 10 metres south of the southern kerbline of Timothy Close in a northerly direction to a point 10 metres north of the northern kerbline of Timothy Close.

Wilton Road, east side, from a point 25 metres south of the southern kerbline of Vandyke Avenue in a northerly direction to a point 10 metres north of the northern kerbline of Vandyke Avenue.

Wilton Road, east side, from a point 35 metres north of the northern kerbline of Vandyke Avenue in a northerly direction for a distance of 26 metres.

Verdun Avenue, both sides, from the western kerbline of Wilton Road in a westerly direction for a distance of 10 metres.

Vauban Drive, both sides, from the western kerbline of Wilton Road in a westerly direction for a distance of 10 metres.

Acacia Drive, both sides, from the western kerbline of Wilton Road in a westerly direction for a distance of 10 metres.

Hawthorn Drive, both sides, from the western kerbline of Wilton Road in a westerly direction for a distance of 10 metres.

Timothy Close, both sides, from the eastern kerbline of Wilton Road in an easterly direction for a distance of 10 metres.

Vandyke Avenue, both sides, from the eastern kerbline of Wilton Road in an easterly direction for a distance of 10 metres.

Voltaire Avenue, south side, from a point 64 metres from the western kerbline of Lancaster Road in a westerly direction for a distance of 27 metres.

Voltaire Avenue, north side, from a point 85 metres from the western kerbline of Lancaster Road in a westerly direction for a distance of 5 metres.

Vestris Drive, west side, from a point 111 metres east of the eastern kerbline of Wilton Road to Voltaire Avenue.

Vestris Drive, west side, from a point 56 metres north of its cul de sac end in a north westerly direction for a distance of 16 metres.

Vestris Drive, east side, from the southern kerbline of Voltaire Avenue in a southerly direction for a distance of 7 metres.

Victoria Road, both sides, from a point 10 metres south of the southern kerbline of Rugby Road in a northerly direction to a point 16 metres north of the northern kerbline of Rugby Road.

Victoria Road, east side, from a point 102 metres north of the northern kerbline of Eccles Old Road in a northerly direction for a distance of 25 metres.

Rugby Road, south side, from its junction with Victoria Road to its junction with Park Road.

Rugby Road, north side, from the western kerbline of Victoria Road in a westerly direction for a distance of 10 metres.

Rugby Road, north side, from the eastern kerbline of Park Road in an easterly direction for a distance of 10 metres.

Park Road, both sides, from a point 10 metres south of the southern kerbline of Rugby Road in a northerly direction to a point 10 metres north of the northern kerbline of Rugby Road.

Vicarage Close, west side, from the southern kerbline of Eccles Old Road in a southerly direction for a distance of 83 metres, then in an easterly and north easterly direction for a distance of 10 metres.

Vicarage Close, east side, from the southern kerbline of Eccles Old Road in a southerly direction for a distance of 18 metres.

Vicarage Close, east side, from a point 36 metres from the southern kerbline of Eccles Old Road in a southerly direction for a distance of 8 metres.

Vicarage Close, east side, from a point 68 metres from the southern kerbline of Eccles Old Road in a southerly and easterly direction for a distance of 10 metres.

Devonshire Road, east side, from a point 64 metres from the southern kerbline of Eccles Old Road in a southerly direction for a distance of 36 metres.

Devonshire Road, west side, from the southern kerbline of Trafalgar Road in a southerly direction for a distance of 15 metres.

Trafalgar Road, both sides, from the western kerbline of Devonshire Road in a westerly direction for a distance of 15 metres.


