The Borough Council of Sandwell (Carter's Green, West Bromwich) (Waiting and Loading Restrictions) Order 2019

The Borough Council of Sandwell ("the Council") in exercise of its powers under Sections 1, 2, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and under the Road Traffic Act 1991 as amended ("the 1991 Act") and of all other enabling powers and after consulting with the Chief Officer of Police in accordance with part III of Schedule 9 to the 1984 Act, hereby makes the following Order: -

 This Order may be cited as The Borough Council of Sandwell (Carter's Green, West Bromwich) (Waiting and Loading Restrictions) Order 2019 and shall come into operation on 12th August 2019.

Interpretation

- 2. In this Order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them: -
 - "Authorised person" means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order.
 - "Council" means Sandwell Metropolitan Borough Council;

"Civil Enforcement Officer"	means an Authorised person by or on behalf of
	the Council to enforce the restrictions in this
	Order and issue Penalty Contravention
	Notices,
"disabled person's badge"	has the same meaning as in the Disabled
	Persons (Badges for Motor Vehicles)

	specified circumstances on a length or lengths

"Parking Place" Mean the part of the road authorised by the Order to be used for the purposes of parking Motor Vehicle

"parking disc"

 Parking Contraventions (England) General
 Regulations 2007 and the provisions of part 6
 of the Traffic Management Act 2004.
 "permit" means a permit issued by the Council under
 the provisions of this Order;

"relevant position"

in respect of: -

- (a) a disabled person's badge and parking disc
 has the same meaning as in the Local
 Authorities' Traffic Orders (Exemptions for
 Disabled Persons) (England) Regulations
 2000; and
- (b) a permit means exhibited behind the windscreen, on the dashboard or fascia of the vehicle or, where the vehicle does not have a windscreen, dashboard or fascia, in conspicuous position on the vehicle so that the whole of the information on the front of the permit is clearly legible from outside the vehicle;

c) A parking disc is displayed in the
 "relevant position" if –

• the disc is exhibited on the dashboard or facia of the vehicle, or

 where the vehicle is not fitted with a dashboard or facia, the disc is exhibited in a conspicuous position on the vehicle, so that, when marked to show the quarter-hour period during which a period of waiting began, that period is clearly legible from the outside of the vehicle.

"restricted hours"	means in relation to any restricted road the

"restricted road"	means any of the sides or lengths of roads		
	where waiting is restricted or specific activities		
	are restricted during the restricted hours		
	provided that the expression "restricted road"

- 3. Any reference in this Order to a numbered Clause shall, unless the context requires otherwise, be construed as a reference to the Clause bearing that number in this Order and any reference to a plan is a reference to a plan incorporated into this Order.
- 4. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament

PROHIBITION AND RESTRICTION OF WAITING

Prohibition of Waiting

- 5. Save as provided in clause 7 to 10 no person shall, except upon the direction or with the permission of a police officer in uniform or Civil Enforcement Officer, cause or permit any Motor Vehicle to wait at any time in the sides and lengths of roads as specified in Schedule 1 to this Order.
- 6. A Motor Vehicle shall be taken to wait on a length of road if
 - i) the Motor Vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle or its load (if any).
 - iii) a further contravention shall be created if the Motor Vehicle remains on a length of road, it will be considered a new contravention from midnight on a rolling/daily basis.
- Nothing in this order shall render it unlawful to cause or permit any Motor Vehicle
 to wait as specified therein for so long as may be necessary
 - a) to enable a person to board or alight from the vehicle;
 - b) to enable the vehicle to be used for the purposes of
 - i) any building operation, demolition or excavation;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of a road;
 - iv) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;

- v) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in Schedule 1 of this Order;
- vi) to enable a vehicle, which is a Universal service provider for the collection or delivery of postal packets in the course of a universal postal service.
- vii) to enable goods to be loaded onto or unloaded from the vehicle;
- c) to enable a Motor Vehicle to be used for police, ambulance, fire
 brigade, local authority, parking attendant/Civil Enforcement Officers or
 water authority, sewage authority and national rivers authority
 purposes, when used in pursuance of their statutory powers or duty.
- d) Nothing in this Order shall render it unlawful to cause or permit a Motor Vehicle which displays in the relevant position, a valid disabled person's badge and a parking disc (on which the Driver or other person in charge of the Motor Vehicle has marked the time at which the period of waiting began) to wait in the sides of lengths of road referred to in Schedule 1 for a period not exceeding 3 hours (provided that this waiting is not during a period separated by an interval of less than 1 hour from a previous period of waiting by the same Motor Vehicle in the same sides of lengths of road).
- 8. Nothing in Clause 5 and Clause 6 shall render it unlawful to cause or permit any vehicle to wait, if it cannot safely and conveniently do so elsewhere, in any of the roads, lengths of road or on the sides of road specified therein if tis an official vehicle being used for funerals or weddings.

- 9. Nothing in Clauses 5 and Clause 6 shall render it unlawful to cause or permit any vehicle to wait upon a designated parking space.
- 10. Nothing in Clause 5 and Clause 6 shall render it unlawful to cause or permit a vehicle to wait in any prohibited or restricted road if it is displaying in the relevant position a valid dispensation certificate issued by the Council and the vehicle is waiting in accordance with the terms and conditions of the said certificate.

PARKING BAYS FOR DISABLED BADGE HOLDERS ONLY

- 11. Subject to the provisions of this section, no person shall, except upon the direction of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any Motor Vehicle to wait in the sides and lengths of roads referred to in Schedule 2 to this Order during the hours prescribed in Column 5 of the said schedule.
- 12. For the purposes of Clause 11, a Motor Vehicle shall be taken to wait on a length of road if
 - i) the Motor Vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle of its load (if any)
 - iii) "For the purposes of Clause 11, a further contravention shall be created if the Motor Vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- 13. Nothing in Clause 11 of this Order shall render it unlawful to cause or permit any Motor Vehicle that displays a valid disabled person's badge in the relevant position, and a parking disc (on which the Driver or other person in charge of the Motor Vehicle has marked the time at which the period of waiting began) to wait in the sides and lengths of roads referred to in Schedule 2 to this Order for a period not exceeding the length of time specified in Column 6 of Schedule 2.
- 14. Nothing in Clause 11 of this Order shall apply to any Motor Vehicle waiting in the sides and lengths of roads referred to in Schedule 2 to this Order during a period separated by interval of less than the duration specified in Column 7 of Schedule 2 from a previous period of waiting by the same Motor Vehicle in the same side and length of road.

15. Nothing in Clause 11 of this order shall render it unlawful to cause or permit any Motor Vehicle to wait as specified therein for so long as may be necessary -

(a) to enable a person to board or alight from the vehicle;

(b) to enable the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with-

- i) any building operation, demolition or excavation;
- ii) the removal of any obstruction to traffic;
- iii) the maintenance, improvement or reconstruction of a road;
- iv) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;
- v) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in Schedule 2 of this Order;
- (c) to enable a vehicle which is a Universal service provider for the collection or delivery of postal packets in the course of a universal postal service.
- (d) to enable goods to be loaded onto or unloaded from the vehicle;
- (e) to enable a Motor Vehicle to be used for police, ambulance, fire brigade, local authority, parking attendant/Civil Enforcement Officers or water authority, sewage authority and national rivers authority purposes, when used in pursuance of their statutory powers or duty.

Limited waiting during prescribed hours

- 16. Subject to the provisions of this section, no person shall, except upon the direction of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any motor vehicle to wait in the sides and lengths of roads referred to in Schedule 3 to this Order during the hours prescribed in Column 5 of the said schedule -
 - (a) for a period exceeding the length of time specified in **Column 6** of **Schedule 3**;
 - (b) during any period separated by an interval of less than the duration specified in Column 7 of Schedule 3 from a previous period of waiting by the same motor vehicle in the same side and length of road.
- 17. For the purposes of **Clause 16**, a motor vehicle shall be taken to wait on a length of road if
 - i) the motor vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle of its load (if any)
 - iii) "For the purposes of **Clause 16**, a further contravention shall be created if the motor vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- 18. Nothing in **Clause 16** of this order shall render it unlawful to cause or permit any motor vehicle to wait as specified therein for so long as may be necessary -
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable the vehicle to be used for the purposes of
 - i) any building operation, demolition or excavation;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of a road;
 - iv) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;
 - v) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in **Schedule 3** of this Order;
 - (c) to enable a vehicle which is a universal service provider for the collection or delivery of postal packets in the course of a universal postal service.
 - (d) to enable goods to be loaded onto or unloaded from the vehicle;

- (e) to enable a motor vehicle to be used for police, ambulance, fire brigade, local authority, parking attendant/civil enforcement officers or water authority, sewage authority and national rivers authority purposes, when used in pursuance of their statutory powers or duty.
- 19. Nothing in **Clause 16** of this Order shall apply to a vehicle that is displaying in the relevant position a valid disabled person's badge.

- 20 Subject to the provisions of this section, no person shall, cause or permit any motor vehicle to be loaded or unloaded in the sides and lengths of roads referred to in **Schedule 4** to this Order during the hours prescribed in **Column 5** of the said schedule.
- 21 For the purposes of **Clause 20**, a motor vehicle shall be taken to wait on a length of road if
 - i) the motor vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle of its load (if any)
 - iii) "For the purposes of Clause 20, a further contravention shall be created if the motor vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- 22 Nothing in **Clause 20** of this order shall render it unlawful to cause or permit any motor vehicle to wait as specified therein for so long as may be necessary -
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable the vehicle to be used for the purposes of
 - i) any building operation, demolition or excavation;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of a road;
 - the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;
 - v) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in Schedule 4 of this Order;
 - (c) to enable a vehicle which is a universal service provider for the collection or delivery of postal packets in the course of a universal postal service.
 - (d) to a motor vehicle which is stationary to enable it to be used for the purposes of the collection and delivery of monies, provided that vehicles referred to in this paragraph shall be only those security vehicles which have been specially made or adapted for that purpose;

(e) to enable a motor vehicle to be used for police, ambulance, fire brigade, local authority, parking attendant/civil enforcement officers or water authority, sewage authority and national rivers authority purposes, when used in pursuance of their statutory powers or duty.

 - iii) "For the purposes of **Clause 23**, a further contravention shall be created if the motor vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- 25 Nothing in **Clause 23** of this order shall render it unlawful to cause or permit any motor vehicle to wait as specified therein for so long as may be necessary -
 - (a) to enable the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with
 - i) any building operation, demolition or excavation;
 - ii) the maintenance, improvement or reconstruction of a road;
 - iii) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;
 - iv) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in Schedule 5 of this Order;
 - (b) to enable a motor vehicle to be used for police, ambulance, fire brigade, local authority, parking attendant/civil enforcement officers or water authority, sewage authority and national rivers authority purposes, when used in pursuance of their statutory powers or duty.
